31	<u>(a) The General</u>	Assembly finds that:

3	(A) Unnecessarily delays patient access to innovative
4	products which can be particularly harmful for citizens of Arkansas who are

8	(3) Other state Medicaid programs provide immediate access to
9	new products and label expansions approved by the United States Food and Drug
10	Administration prior to a formal clinical review; and
11	(4) It is in the best interest of the citizens of this state to
12	provide immediate access to new products and label expansions approved by the
13	United States Food and Drug Administration prior to a formal clinical review.
14	(b) Consistent with federal laws and regulations, the Arkansas
15	Medicaid Program shall:
16	(1) Provide immediate access to and reimbursement for new
17	products and label expansions approved by the United States Food and Drug
18	Administration, or outpatient drugs with a federal rebate agreement in place,
19	if the product is prescribed according to approved indications or medically
20	accepted indications; and
21	(2) Not deny or delay coverage or reimbursement for new products
22	and label expansions for an existing covered product approved by the United
23	States Food and Drug Administration for an existing covered product,
24	including denying or delaying access to a product solely because the Arkansas
25	Medicaid Drug Utilization Review Board or any other advisory body has not
26	conducted a formal clinical review of the product or label expansion.

28	SECTION 2. Arkansas Code Title 25, Chapter 10, Subchapter 1, is
29	amended to add an additional section to read as follows:
30	<u> 25-10-145. Rare Disease Advisory Council — Creation.</u>
31	(a) As used in this section, "rare disease or condition" means any
32	disease or condition that affects:
33	(1) Less than two hundred thousand (200,000) persons in the
34	<u>United States; or</u>
35	(2) More than two hundred thousand (200,000) persons in the
36	United States and for which there is no reasonable expectation that the cost

4	(b) There is established the Rare Disease Advisory Council within the	
5	Department of Human Services.	
6	(c) The purposes of the council are to:	
7	(1)(A) Provide expert, clinical advice and input in writing to	
8	the Arkansas Medicaid Drug Utilization Review Board when the board reviews a	
9	drug or treatment for a rare disease or condition.	
10	(B) The board shall:	
11	(i) Seek advice and feedback on drafts of clinical	
12	criteria from the council before reviewing any treatment or drug that treats	
13	<u>a rare disease or condition;</u>	
14	(ii) Distribute the advice of the council to the	
15	members of the board; and	
16	(iii) Publish the advice of the council in the	
17	meeting minutes of the board;

32	(d)(1) The council shall consist of twelve (12) voting members to be	
33	appointed as follows:	
34	(A)(i) Four (4) members appointed by the Governor.	
35	(ii) One (1) member appointed by the Governor shall	
36	be a representative from the department.

22	Tempore of the Senate shall be a geneticist who is licensed and practicing in
23	the state;
24	(C)(i) Three (3) members appointed by the Speaker of the
25	House of Representatives.
26	(ii) One (1) member appointed by the Speaker of the
27	House of Representatives shall be a representative from an academic research
28	institution in the state that receives grant funding for rare disease or
29	condition research.
30	(iii) One (1) member appointed by the Speaker of the
31	House of Representatives shall be a physician who is licensed and practicing
32	in the state and has experience in researching, diagnosing, or treating rare
33	diseases or conditions.
34	(iv) One (1) member appointed by the Speaker of the
35	House of Representatives shall be a registered nurse or advanced practice
36	registered nurse who is licensed and practicing in the state and has

2	(D) One (1) member appointed by the Chair of the Senate	
3	Committee on Public Health, Welfare, and Labor; and	
4	(E) One (1) member appointed by the Chair of the House	
5	Committee on Public Health, Welfare, and Labor.	
6	(2) A member of the council shall not be a current member of the	
7	board or any other drug utilization advisory group to the Arkansas Medicaid	
8	Program.	
9	(e)(1)(A) At the first meeting of the council, the length of the terms	
10	of the initial appointees shall be determined by lot.	
11	(B) A member subsequently appointed to the council shall	
12	serve a term of two (2) years.	
13	(2)(A) A vacancy on the council shall be filled in the same	
14	manner as the initial appointment.	
15	(B) A member appointed to fill a vacancy shall serve for	
16	the remainder of the vacated term.	
17	(3) Members may be removed by the appointing official for cause.	
18	(f) The department shall provide offices and staff for the council.	
19	(g) The council shall annually elect a chair and vice-chair from its	
20	membership.	
21	(h)(1) A majority of the membership of the council constitutes a	
22	quorum.	
23	(2) A majority vote of the members present is required for any	
24	action of the council.	
25	(3) Members may participate in meetings electronically via	
26	teleconference and be considered present.	
27	(i) The council may appoint subcommittees to study, research, and	
28	advise the council.	
29	(j) With the exception of members who are employed by the state,	
30	members may receive expense reimbursement and stipends under § 25-16-901 et	
31	seq.	
32	(k) The council shall submit an annual report to the Governor, the	
33	General Assembly, the department, and other relevant agencies that:	
34	(1) Describes the findings, activities, and progress of the	
35	council; and	
36	(2) Provides feedback on ways to address the needs of people
