- 26 SECTION 33. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 27 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EDUCATOR
- 28 COMPENSATION REFORM SUB-FUND. Upon the effective date of this Act, or as
- 29 soon thereafter as practical, the Arkansas State Treasurer shall transfer
- 30 \$60,000,000 from the Educational Adequacy Fund to the Public School Fund to
- 31 be used solely for the implementation of the Educator Compensation Reform

- SECTION 34. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS

 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ENHANCED

 STUDENT ACHIEVEMENT FUNDING NAME CHANGE. Any appropriation titled "ENHANCED

 STUDENT ACHIEVEMENT FUNDING" or abbreviated as "ESA" as named by SB605 of

 2019 may also be known as "NATIONAL SCHOOL LUNCH" funding or abbreviated as

 "NSL" and shall be used for the same purposes as set out in law.
- The provisions of this section shall be in effect only from July 1, $\frac{2020}{2021}$ through June 30, $\frac{2021}{2022}$.

SECTION 35. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Procurement Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

1	General Assembly, that the Constitution of the State of Arkansas prohibits
2	the appropriation of funds for more than a one (1) year period; that the
3	effectiveness of this Act on July 1, 2021, with the exception that section 7
4	of this Act shall be effective upon passage and approval, is essential to the
