1	SECTION 2. Arkansas Code § 14-285-102(b), concerning the time and
2	manner of payment of annual installments of the assessment of benefits in a
3	municipal recreation improvement district, is amended to read as follows:
4	(b) If the annual installments are delinquent at the time the realty
5	subject to a lien for delinquent annual installments is sold for delinquent
6	taxes and the municipal recreation improvement district has not forgiven the
7	delinquency, the State Land Commissioner Commissioner of State Lands shall
8	recover the delinquent annual installments at the time of the sale thereby
9	relieving the district <u>municipal recreation improvement district</u> of the
10	requirement of instituting a civil action for foreclosure.
