- 7 (2)(A) A citizen may make a request to the custodian to inspect,
- 8 copy, including without limitation by taking a photograph, or receive copies
- 9 of public records.
- 10 (B) The request may be made in person, by telephone, by
- ll mail, by facsimile transmission, by electronic mail, or by other electronic
- 12 means provided by the custodian.
- 13 (C) The request shall be sufficiently specific to enable
- 14 the custodian to locate the records with reasonable effort.

- SECTION 3. Arkansas Code § 25-19-105(d)(1), concerning the access to
- 17 public records for examination and copying under the Freedom of Information
- 18 Act of 1967, is amended to read as follows:
- 19 (d)(1) Reasonable access to public records and reasonable comforts and
- 20 facilities for the full exercise of the right to inspect and copy, including
- 21 without limitation copying by taking a photograph, those records shall not be
- 22 denied to any citizen.

- 24 SECTION 4. Arkansas Code § 25-19-105(d)(3)(A), concerning the fee for
- 25 examination and copying of public records under the Freedom of Information
- 26 Act of 1967, is amended to add an additional subdivision to read as follows:
- 27 (v) Except as provided in § 25-19-109, the custodian
- 28 may not charge a fee for the inspection or copying, including without
- 29 <u>limitation copying by taking a photograph, of public records.</u>

- 31 SECTION 5. Arkansas Code § 25-19-105(f)(4), concerning the denial of
- 32 the right of examination and copying of public records under the Freedom of
- 33 Information Act of 1967, is amended to read as follows:
- 34 (4) If it is necessary to separate exempt from nonexempt
- 35 information in order to permit a citizen to inspect, copy, including without
- 36 <u>limitation copying by taking a photograph</u>, or obtain copies of public
