1 (i) A person who at the time of the request has 2 pleaded guilty to or been found guilty of a felony and is incarcerated in a 3 correctional facility; and 4 (ii) The representative of a person under 5 subdivision (a)(1)(B)(i) of this section unless the representative is the 6 person's attorney who is requesting information that is subject to disclosure 7 under this section. 8 (2)(A) A citizen may make a request to the custodian to inspect, copy, including without limitation by taking a photograph, or receive copies 9 10 of public records. 11 (B) The request may be made in person, by telephone, by 12 mail, by facsimile transmission, by electronic mail, or by other electronic 13 means provided by the custodian. 14 (C) The request shall be sufficiently specific to enable 15 the custodian to locate the records with reasonable effort. 16 17 SECTION 3. Arkansas Code § 25-19-105(d)(1), concerning the access to 18 public records for examination and copying under the Freedom of Information 19 Act of 1967, is amended to read as follows: 20 (d)(1) Reasonable access to public records and reasonable comforts and 21 facilities for the full exercise of the right to inspect and copy, including 22 without limitation copying by taking a photograph, those records shall not be 23 denied to any citizen. 24 25 SECTION 4. Arkansas Code § 25-19-105(d)(3)(A), concerning the fee for 26 examination and copying of public records under the Freedom of Information 27 Act of 1967, is amended to add an additional subdivision to read as follows: 28 (v) Except as provided in § 25-19-109, the custodian 29 may not charge a fee for the inspection or copying, including without 30 limitation copying by taking a photograph, of public records. 31 32 SECTION 5. Arkansas Code § 25-19-105(f)(4), concerning the denial of 33 the right of examination and copying of public records under the Freedom of 34 Information Act of 1967, is amended to read as follows: 35 (4) If it is necessary to separate exempt from nonexempt 36 information in order to permit a citizen to inspect, copy, including without
