Actual service requirement. 17 (a)(1) Benefits and eligibility for benefits under this subchapter 18 shall be based on the following: (A) actual Actual service in the Arkansas Judicial 19 20 Retirement System; and 21 (B) Service credit purchased under § 24-8-718. 22 (2) The provisions of § 24-2-401 et seq. may be used to meet the 23 service requirements of this subchapter. 24 (b) Laws Except as otherwise provided by subsection (a) of this 25 section, laws allowing the purchase of credited service or providing free 26 credited service shall not apply to this subchapter. However, the provisions 27 of § 24-2-401 et seq. may be used to meet the service requirements of this 28 subchapter. 29 30 SECTION 3. Arkansas Code Title 24, Chapter 8, Subchapter 7, is amended 31 to add an additional section to read as follows: 32 24-8-718. Service credit purchase by member of General Assembly. 33 (a) A current or former member of the General Assembly who later becomes a member of the Arkansas Judicial Retirement System may purchase 34 credit in the system for his or her service as a member of the General 35 36 Assembly if the person:
