SECTION 2. Arkansas Code Title 27, Chapter 20, Subchapter 2, is amended to add an additional section to read as follows: 27-20-209. Vehicle identification number verification. Vehicle identification number verification is required under § 27-14-725 prior to the sale of a three-wheeled, four-wheeled, or six-wheeled all-terrain vehicle.
