20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22	SECTION 1. REAPPROPRIATION - DIVISION OF YOUTH SERVICES. There is	_S
23	hereby appropriated, to the Department of Human Services, to be payable	from
24	the Development and Enhancement Fund, for the Department of Human Servi	ces -
25	Division of Youth Services the following:	
26	(A) Effective July 1, 2021, the balance of the appropriation pro	vided
27	in Item (A) of Section 1 of Act 113 of 2020, for maintenance of resider	ntial
28	facilities, in a sum not to exceed\$1,50	00,000.
29	(B) Effective July 1, 2021, the balance of the appropriation pro	vided
30	in Item (B) of Section 1 of Act 113 of 2020, for upgrades to surveillar	ıce
31	systems at the Harrisburg, Lewisville, Mansfield, Dermott, and Arkansas	;
32	Juvenile Assessment and Treatment Center facilities, in a sum not to ex	ceed
33	\$3,70	00,000.
34	(C) Effective July 1, 2021, the balance of the appropriation pro	vided
35	in Item (D) of Section 1 of Act 113 of 2020, for improvements to the ro	ad at
36	the Mansfield residential facility, in a sum not to exceed\$5	50,000.

- 6 (E) Effective July 1, 2021, the balance of the appropriation provided 7 in Item (F) of Section 1 of Act 113 of 2020, for the removal of buildings at 8 the Mansfield and Arkansas Juvenile Assessment and Treatment Center 9 facilities, in a sum not to exceed ......\$800,000.

- SECTION 2. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor obligations otherwise incurred in relation to the project or projects described herein in excess of the State Treasury funds actually available therefor as provided by law. Provided, however, that institutions and agencies listed herein shall have the authority to accept and use grants and donations including Federal funds, and to use its unobligated cash income or funds, or both available to it, for the purpose of supplementing the State Treasury funds for financing the entire costs of the project or projects enumerated herein. Provided further, that the appropriations and funds otherwise provided by the General Assembly for Maintenance and General Operations of the agency or institutions receiving appropriation herein shall not be used for any of the purposes as appropriated in this act.
- (B) The restrictions of any applicable provisions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law and any other applicable fiscal control laws of this State and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of any funds provided by this act unless specifically provided otherwise by law.

Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or

4	SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General	
5	Assembly, that the Constitution of the State of Arkansas prohibits the	
6	appropriation of funds for more than a one (1) year period; that the	
7	effectiveness of this Act on July 1, 2021 is essential to the operation of	
8	the agency for which the appropriations in this Act are provided, and that in	
9	the event of an extension of the legislative session, the delay in the	
10	effective date of this Act beyond July 1, 2021 could work irreparable harm	
11	upon the proper administration and provision of essential governmental	
12	programs. Therefore, an emergency is hereby declared to exist and this Act	
13	being necessary for the immediate preservation of the public peace, health	
14	and safety shall be in full force and effect from and after July 1, 2021.
