1	(2) As a result of so many students qualifying for free or
2	reduced-price lunch, some students may face more challenges than others in
3	succeeding in school and in life and can benefit from additional support;
4	(3) Community schools provide comprehensive programs and
5	services to meet the needs of the whole child, which include without
6	limitation adequate health care, mental health care, dental care, nutrition,
7	and trauma support services, so that students can reach their full potential;
8	(4) Not all families are able to provide academic support and
9	enrichment opportunities outside of school that help children and youth
10	develop educational, social, emotional, and physical skills throughout and
11	during out-of-school time;
12	(5) Community schools play a vital role in ensuring that all
13	students have access to opportunities that support success;
14	(6) Community schools support working families by ensuring all
15	children and youth are safe and productive, even during out-of-school time;
16	(7) Community schools help build strong communities by involving
17	students, parents, business leaders, and adult volunteers in the lives of
18	young people in positive and productive activities;
19	(8) Research shows that community school strategies can result
20	in improvements in a variety of student outcomes, including higher attendance
21	rates, higher aspirations toward finishing school and going to college, fewer
22	discipline issues, and cultivation of positive bonds with people and
23	institutions that are reflected in students' exchanges with peers, family,
24	school, and community;
25	(9) Research further shows that community school programs offer
26	a strong return on investment of up to fifteen dollars (\$15.00) for every one
27	dollar (\$1.00) invested in community schools;
28	(10) Community schools are a means through which the State of
29	Arkansas may promote the goal of encouraging federal, state, and local
30	governments to work with community-based organizations in order to improve
31	the coordination, delivery, effectiveness, and efficiency of services
32	provided to students and families;
33	(11) In evidence of this, federal funding can be used to support
34	community schools, and research demonstrates that community schools meet the
35	standard under 20 U.S.C. § 6301 et seq. for "evidence-based" approaches to
36	support schools identified for comprehensive and targeted support and

1	intervention; and
2	(12) Further guidelines and assistance for community school
3	strategies are provided through the Full-Service Community Schools Program of
4	the Office of Elementary and Secondary Education of the United States
5	Department of Education.
6	
7	6-15-3003. Definitions.
8	As used in this subchapter:
9	(1)(A) "Community school" means a public school that implements
10	a service and inclusion strategy that coordinates resources and relationships
11	in order to accelerate equitable outcomes.
12	(B) Community school strategies may vary among public
13	schools based on the needs of individual communities, but at a minimum
14	include the following without limitation:
15	(i) The four (4) key pillars of an evidence-based
16	community school approach, which include:
17	(a) Integrated student supports;
18	(b) Expanded and enriched learning time and
19	opportunities;
20	(c) Active family and community engagement;
21	and
22	(d) Collaborative leadership and practices
23	that:
24	(1) Promote conditions found in high-
25	quality schools; and
26	(2) Address out-of-school barriers to
27 28	learning;
29	(ii) A community school coordinator at each community school site; and
30	(iii) A community school plan;
31	(2)(A) "Community school coordinator" means a designated site
32	resource coordinator at a public school or local education agency that
33	provides a variety of resources, including without limitation partnerships
34	with community resources, and whose primary responsibilities include without
35	limitation:
36	(i) Leading needs and assets analyses;

1	(ii) Facilitating development and implementation of
2	a community school plan in collaboration with other members of school-based
3	<pre>leadership;</pre>
4	(iii) Building relationships between the school and
5	community partners for the provision of identified supports and services; and
6	(iv) Connecting public school students and families
7	to services and opportunities.
8	(B) To the extent possible, the responsibilities of a
9	community school coordinator may be undertaken in coordination with a parent
10	facilitator appointed under § 6-15-1702; and
11	(3) "Community school plan" means a plan that establishes how
12	educators, school staff, governmental entities, and community partners will
13	use and leverage all available assets to meet specific student and family
14	needs in order to improve opportunities and outcomes for students.
15	
16	6-15-3004. Assistance by Division of Elementary and Secondary
17	Education.
18	The Division of Elementary and Secondary Education may:
19	(1) Develop guidelines consistent with those that are provided
20	through the Full-Service Community Schools Program of the Office of
21	Elementary and Secondary Education of the United States Department of
22	Education;
23	(2) Provide targeted professional development programs that
24	teach the competencies required for:
25	(A) Managing successful community schools and expanded
26	<pre>learning time;</pre>
27	(B) Planning and implementing services and strategies in
28	collaboration with communities; and
29	(C) Blending and braiding funding to support community
30	schools;
31	(3)(A) Require sufficient data to:
32	(i) Enable oversight of community schools; and
33	(ii) Inform ongoing school improvement.
34	(B) The division may also collect leading indicators and
35	process data to better understand the degree to which the community school
36	approach is being implemented; and

4	SECTION 2. Arkansas Code § 6-15-2916(2), concerning the authority of
5	the State Board of Education over a public school district classified as in
6	need of Level 5 - Intensive support, is amended to add an additional
7	subdivision to read as follows:
8	(L) Require a structured system of whole child supports
9	through a community school plan, as defined by § 6-15-3003.
10	
11	SECTION 3. Arkansas Code Title 6, Chapter 23, Subchapter 1, is amended
12	to add an additional section to read as follows:
13	6-23-109. Community schools.
14	(a) The authorizer may designate a public charter school as a
15	community school, as defined by § 6-15-3003.
16	(b) To be designated as a community school, the applicant shall
17	include in its original application or charter amendment request:
18	(1) A request to be designated as a community school; and
19	(2) A community school plan, as defined by § 6-15-3003, which
20	shall include without limitation an initial plan for serving student needs.
21	
22	SECTION 4. Arkansas Code § 6-23-201(a)(2)(A), concerning a public
23	school's application for conversion public charter school status, is amended
24	to read as follows:
25	(A) Adopting research-based school or instructional
26	designs, or both, that focus on improving student and school performance,
27	which may include without limitation the implementation of a community school
28	plan, as defined by § 6-15-3003;
29	
30	SECTION 5. Arkansas Code § 6-23-302(c)(2), concerning an application
31	to become an open-enrollment public charter school, is amended to read as
32	follows:
33	(2) Describe a plan for academic achievement that addresses how
34	the open-enrollment public charter school will improve student learning and
35	meet the state education goals, which may include without limitation the
36	implementation of a community school plan, as defined by § 6-15-3003;

2	SECTION 6. EMERGENCY CLAUSE. It is found and determined by the
3	General Assembly of the State of Arkansas that the coronavirus 2019 (COVID-
4	19) pandemic has resulted in substantial disruption to the educational system
5	in the state's kindergarten through grade twelve (K-12) public schools and
6	open-enrollment public charter schools; that amendments to the law as
7	provided in this act are needed to address challenges faced by Arkansas
8	students in succeeding in school and in life; and that this act is
9	immediately necessary to maintain the orderly operation of public schools and
10	open-enrollment public charter schools so that students in this state
11	continue to receive an adequate education. Therefore, an emergency is
12	declared to exist, and this act being immediately necessary for the
13	preservation of the public peace, health, and safety shall become effective
14	on:
15	(1) The date of its approval by the Governor;
16	(2) If the bill is neither approved nor vetoed by the Governor,
17	the expiration of the period of time during which the Governor may veto the
18	bill; or
19	(3) If the bill is vetoed by the Governor and the veto is
20	overridden, the date the last house overrides the veto.
