20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22	SECTION 1. Arkansas Code Title 26, Chapter 51, Subchapter 5, is	
23	amended to add an additional section to read as follows:	
24	26-51-515. Full-time law enforcement officer tax credit.	
25	(a) As used in this section:	
26	(1) "Full-time law enforcement officer" means a law enfor	<u>cement</u>
27	officer who:	
28	(A) Is employed by and receives a salary authorized	by a
29	law enforcement agency;	
30	(B) Has the statutory authority to enforce the crim	<u>inal,</u>
31	traffic, or highway laws of the state or of the federal government; an	<u>1</u>
32	(C) Has worked for a law enforcement agency for at	<u>Least</u>
33	twenty-five (25) hours per week for at least eleven (11) months of the	
34	calendar year; and	
35	(2) "Law enforcement agency" means a municipal police	
36	department, a county sheriff's office, a law enforcement entity of the	State

1	of Arkansas, including without limitation the Division of Arkansas State	
2	Police, or a federal law enforcement entity.	
3	(b) There is allowed an income tax credit against the income tax	
4	imposed by this chapter in the amount of three thousand dollars (\$3,000) for	
5	a taxpayer who obtains verification as stated in subsection (c) of this	
6	section.	
7	(c) A taxpayer may receive the credit under subsection (b) of this	
8	section if the taxpayer obtains verification as follows:	
9	(1) If the taxpayer is the chief law enforcement officer of a	
10	law enforcement agency, the taxpayer shall obtain written verification on a	
11	form approved by the Department of Finance and Administration that:	
12	(A) States that the taxpayer is a full-time law	
13	enforcement officer; and	
14	(B) Is signed by the second most senior law enforcement	
15	officer and the payroll clerk of the law enforcement agency; and	
16	(2) If the taxpayer is not the chief law enforcement officer of	
17	the law enforcement agency, the taxpayer shall obtain written verification on	
18	a form approved by the department that:	
19	(A) States that the taxpayer is a full-time law	
20	enforcement officer; and	
21	(B) Is signed by the taxpayer's immediate supervisor and	
22	the chief law enforcement officer of the law enforcement agency.

24	SECTION 2. EFFECTIVE DATE. Section 1 of this act is effective for tax	
25	years beginning on or after January 1, 2021.
