25	(a) Beginning October 1, 2021, a foreign person required to make a
26	report to the United States Department of Agriculture under the Agricultural
27	Foreign Investment Disclosure Act, 7 U.S.C. § 3501 et seq., shall also file a
28	copy of the required report with the Secretary of the Arkansas Department of
29	Agriculture within the time period required under the federal law.
30	(b) The Attorney General:
31	(1) Shall impose a civil penalty not to exceed twenty-five
32	percent (25%) of the fair market value, on the date of the assessment of the
33	penalty, of the interest in the agricultural land for failure to file a copy
34	of the report with the Secretary of the Arkansas Department of Agriculture as
35	required under subsection (a) of this section; and
36	(2) May bring an action to collect the civil penalty in the

1	Pulaski County Circuit Court or in the circuit court of any county in which
2	any portion of the agricultural land acquired is located.
3	(c) The Arkansas Agricultural Foreign Investment Act, § 2-3-101 et
4	seq. is suspended while the Agricultural Foreign Investment Disclosure Act, 7
5	U.S.C. § 3501 et seq., is in effect.
6	(d) This section shall expire upon the repeal of the Agricultural
