## For An Act To Be Entitled

8 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES  
9 AND OPERATING EXPENSES FOR THE UNIVERSITY OF ARKANSAS  
10 AT PINE BLUFF WHICH SHALL BE SUPPLEMENTAL AND IN  
11 ADDITION TO THOSE FUNDS APPROPRIATED BY ACT 138 OF  
12 2020; AND FOR OTHER PURPOSES.

## Subtitle

15 AN ACT FOR THE UNIVERSITY OF ARKANSAS AT  
16 PINE BLUFF SUPPLEMENTAL APPROPRIATION.

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. APPROPRIATION - STATE OPERATIONS. There is hereby  
23 appropriated, to the University of Arkansas at Pine Bluff, to be payable from  
24 the University of Arkansas at Pine Bluff Fund, for personal services and  
25 operating expenses of the University of Arkansas at Pine Bluff which shall be  
26 supplemental and in addition to those funds appropriated in Section 3 of Act  
27 138 of 2020, the following:

5 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
6 authorized by this act shall be limited to the appropriation for such agency  
7 and funds made available by law for the support of such appropriations; and  
8 the restrictions of the State Procurement Law, the General Accounting and  
9 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
10 Procedures and Restrictions Act, or their successors, and other fiscal  
11 control laws of this State, where applicable, and regulations promulgated by  
12 the Department of Finance and Administration, as authorized by law, shall be  
13 strictly complied with in disbursement of said funds.

15 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General  
16 Assembly that any funds disbursed under the authority of the appropriations  
17 contained in this act shall be in compliance with the stated reasons for  
18 which this act was adopted, as evidenced by the Agency Requests, Executive  
19 Recommendations and Legislative Recommendations contained in the budget  
20 manuals prepared by the Department of Finance and Administration, letters, or  
21 summarized oral testimony in the official minutes of the Arkansas Legislative  
22 Council or Joint Budget Committee which relate to its passage and adoption.

24 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General  
25 Assembly, that funds provided by the General Assembly for the operations of  
26 the University of Arkansas at Pine Bluff are, due to unforeseen  
27 circumstances, insufficient for the University of Arkansas at Pine Bluff to  
28 continue to provide essential governmental services; that the provisions of  
29 this act will provide the necessary monies for the University of Arkansas at  
30 Pine Bluff to continue such services; and that a delay in the effective date  
31 of this Act could work irreparable harm upon the proper administration and  
32 provision of essential governmental programs. Therefore, an emergency is  
33 hereby declared to exist and this Act being necessary for the immediate  
34 preservation of the public peace, health and safety shall be in full force  
35 and effect from and after the date of its passage and approval.

If the bill is neither approved nor vetoed by the Governor, it shall

1 become effective on the expiration of the period of time during which the  
2 Governor may veto the bill. If the bill is vetoed by the Governor and the  
3 veto is overridden, it shall become effective on the date the last house  
4 overrides the veto.
