20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22	SECTION 1. APPROPRIATION - STATE OPERATIONS. There is hereby			
23	appropriated, to the University of Arkansas at Fayetteville, to be payable			
24	from the University of Arkansas Fund, for personal services of the University			
25	of Arkansas at Fayet	teville which shall be supplemental	and in addition to	
26 27	those funds appropria	ated in Section 3 of Act 136 of 2020	O, the following:

34	SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds			
35	authorized by this act shall be limited to the appropriation for such agency			
36	and funds made available by law for the support of such appropriations, and			

1 the restrictions of the State Procurement Law, the General Accounting and 2 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal 3 4 control laws of this State, where applicable, and regulations promulgated by 5 the Department of Finance and Administration, as authorized by law, shall be 6 strictly complied with in disbursement of said funds. 7 8 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General 9 Assembly that any funds disbursed under the authority of the appropriations 10 contained in this act shall be in compliance with the stated reasons for 11 which this act was adopted, as evidenced by the Agency Requests, Executive 12 Recommendations and Legislative Recommendations contained in the budget 13 manuals prepared by the Department of Finance and Administration, letters, or 14 summarized oral testimony in the official minutes of the Arkansas Legislative 15 Council or Joint Budget Committee which relate to its passage and adoption. 16 17 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General 18 Assembly, that funds provided by the General Assembly for the operations of 19 the University of Arkansas at Fayetteville are, due to unforeseen 20 circumstances, insufficient for the University of Arkansas at Fayetteville to 21 continue to provide essential governmental services; that the provisions of 22 this act will provide the necessary monies for the University of Arkansas at 23 Fayetteville to continue such services; and that a delay in the effective date of this Act could work irreparable harm upon the proper administration 24 25 and provision of essential governmental programs. Therefore, an emergency is 26 hereby declared to exist and this Act being necessary for the immediate 27 preservation of the public peace, health and safety shall be in full force and effect from and after the date of its passage and approval. 28 29 If the bill is neither approved nor vetoed by the Governor, it shall 30 become effective on the expiration of the period of time during which the Governor may veto the bill. If the bill is vetoed by the Governor and the 31 32 veto is overridden, it shall become effective on the date the last house 33 overrides the veto.
