22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. Arkansas Code § 6-4-304(a)(6)-(8), concerning the creation
25 of the State Council, are amended to read as follows:

26 (6) The charter school leader of the open-enrollment public
27 charter school with the greatest number of children of military families as
28 determined every four (4) years;

29 (7)~~(A)~~ A representative from each federal and state military
30 installation in Arkansas that employs uniformed service members as ~~designated~~
31 appointed by each military installation commander-

32 ~~(B) A representative from a federal military installation~~
33 ~~shall serve as a nonvoting, ex officio member;~~

34 (8) The Executive Director of the Arkansas Activities
35 Association, ~~serving as a nonvoting, ex officio member;~~

1 SECTION 2. Arkansas Code § 6-4-304(b)(2)(B), concerning the creation
2 of the State Council, is amended to read as follows:

3 (B) Each succeeding appointment to the council shall be
4 for a term of ~~five (5)~~ four (4) years, but the member appointed shall serve
5 until the member's successor is appointed.

7 SECTION 3. Arkansas Code § 6-4-305(f)(2), concerning the duties of the
8 State Council, is amended to read as follows:

9 (2) Details of the reports regarding the compact in this state
10 that are provided to the national Military Interstate Children's Compact
11 ~~Council Commission~~ and actions taken by the national Military Interstate
12 Children's Compact ~~Council Commission~~ that impact the state;

14 SECTION 4. Arkansas Code § 6-4-306(a), concerning the military family
15 education liaison, is amended to read as follows:

16 (a) The military family education liaison shall be ~~an ex-officio~~ a
17 nonvoting member of the State Council for the Interstate Compact on
18 Educational Opportunity for Military Children.
