30	22-4-305. Authority of State Parks, Recreation, and Travel Commission
31	to impose fees for services - Pledge of revenues from fees - Restrictions.
32	(a) <u>(l)</u> The State Parks, Recreation, and Travel Commission is
33	authorized and directed to shall direct the State Parks Division to prescribe
34	and collect reasonable fees, rates, tolls, and charges for the services,
35	facilities, and commodities rendered by the properties and equipment of the
36	state parks system.

20	<u>Arkansas Administrative Procedure Act, § 25-15-201 et seq.</u>
21	(b) The authority and power of the commission includes the right to
22	erect and operate cabins, lodges, restaurants, and other facilities and
23	improvements for the convenience of the public and the right to erect and
24	lease to third parties for operation such facilities and improvements upon
25	such terms as the commission may determine.
26	(c)(l) The commission shall revise the rates, fees, tolls, charges,
27	and rentals whenever necessary to ensure that the revenues therefrom from
28	rates, fees, tolls, charges, and rentals, together with other available
29	funds, shall be fully sufficient to discharge all obligations of the
30	commission pertaining to the principal of and interest on any bonds as the
31	principal and interest become due.
32	(2) The gross revenue derived by the commission from all or any
33	part of the properties and equipment of the state parks system may be pledged
34	to the payment of revenue bonds authorized to be issued by this subchapter
35	even though the proceeds from a particular bond issue may be used for the
36	development or improvement of one (1) or more, but less than all, state
