SECTION 16. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 5 6 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. USE OF 7 ADVA CONTINGENCY POSITION POOL AND CONTINGENCY APPROPRIATION. In the event 8 additional appropriation becomes necessary that is not authorized or 9 contemplated in State Operations, Veterans' Homes and Veterans' Cemeteries 10 appropriations of this Act and growth in the State Veterans' Home at 11 Fayetteville's or North Little Rock's resident census and/or growth in the 12 number of interments at the State Veterans' Cemetery at North Little Rock 13 makes it necessary for the Arkansas Department of Veterans' Affairs to 14 request additional positions, regular salaries and personal services matching 15 appropriation in order to carry out the objectives of the Agency, the ADVA 16 Contingency Position Pool and Contingency Appropriation authorized herein may 17 be used for regular salaries and personal services matching line items.

18 The Arkansas Department of Veterans' Affairs Contingency Appropriation 19 authorized herein shall be funded primarily with cash funds of the State 20 Veterans' Home at Fayetteville <u>or North Little Rock</u> and of the State 21 Veterans' Cemetery at North Little Rock <u>or Birdeye</u>. Each entity's cash funds 22 shall be utilized in support of its own business operations and shall not be 23 co-mingled. In addition, general revenue funding in support of the ADVA 24 Contingency Position Pool shall be limited to \$250,000 per year.

Use of the ADVA Contingency Position Pool and Contingency Appropriation authorized in this Act shall be conditioned upon approval by the Chief Fiscal Officer of the State and upon certification by the <u>Director Secretary</u> of the Arkansas Department of Veterans' Affairs that funds are available to support the contingency positions requested and upon prior review by the Arkansas Legislative Council or Joint Budget Committee.

The General Assembly has determined that the Arkansas State Veterans' Home at Fayetteville and the Arkansas State Veterans' Cemetery at North Little Rock may operate more efficiently if some flexibility is provided to the Arkansas Department of Veterans' Affairs under this Section.

SECTION 17. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 18 19 authorized by this act shall be limited to the appropriation for such agency 20 and funds made available by law for the support of such appropriations; and 21 the restrictions of the State Procurement Law, the General Accounting and 22 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary 23 Procedures and Restrictions Act, or their successors, and other fiscal 24 control laws of this State, where applicable, and regulations promulgated by 25 the Department of Finance and Administration, as authorized by law, shall be 26 strictly complied with in disbursement of said funds.

28 SECTION 18. LEGISLATIVE INTENT. It is the intent of the General 29 Assembly that any funds disbursed under the authority of the appropriations 30 contained in this act shall be in compliance with the stated reasons for 31 which this act was adopted, as evidenced by the Agency Requests, Executive 32 Recommendations and Legislative Recommendations contained in the budget 33 manuals prepared by the Department of Finance and Administration, letters, or 34 summarized oral testimony in the official minutes of the Arkansas Legislative 35 Council or Joint Budget Committee which relate to its passage and adoption. 36

1	SECTION 19. EMERGENCY CLAUSE. It is found and determined by the			
2	General Assembly, that the Constitution of the State of Arkansas prohibits			
3	the appropriation of funds for more than a one (1) year period; that the			
4	effectiveness of this Act on July 1, 2021 is essential to the operation of			
5	the agency for which the appropriations in this Act are provided, and that in			
6	the event of an extension of the legislative session, the delay in the			
7	effective date of this Act beyond July 1, 2021 could work irreparable harm			
8	upon the proper administration and provision of essential governmental			
9	programs. Therefore, an emergency is hereby declared to exist and this Act			
10	being necessary for the immediate preservation of the public peace, health			
11	and safety shall be in full force and effect from and after July 1, 2021.
