20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22	SECTION 1. Arkansas Code Title 6, Chapter 60, is amended to add	an
23	additional subchapter to read as follows:	
24	Subchapter 12 — Transparency in Foreign Investment Act	
25		
26	6-60-1201. Title.	
27	This subchapter shall be known and may be cited as the "Transparen	ncy in
28	Foreign Investment Act".	
29		
30	6-60-1202. Definitions.	
31	As used in this subchapter:	
32	(1) "Confucius Institute" means a Confucius Institute opera	<u>ated</u>
33	by the Office of Chinese Language Council International, also known as	<u>the</u>
34	"Haban", which is affiliated with the Ministry of Education of the Peop	<u>le's</u>
35	Republic of China;	
36	(2) "Contract" means an agreement for the acquisition by	

1	purchase, lease, or barter of property or services between a foreign source
2	and an institution for the direct benefit of or use by either of the parties;
3	(3) "Foreign source" means:
4	(A) A foreign government, including without limitation an
5	agency of a foreign government;
6	(B) A legal entity, government or otherwise, created
7	solely under the laws of a foreign state or states;
8	(C) An individual who is not a citizen or a national of
9	the United States or a trust territory or a protectorate of a trust
10	territory; or
11	(D) An agent, including without limitation a subsidiary or
12	affiliate of a foreign legal entity, acting on behalf of a foreign source, as
13	described by subdivisions (3)(A)-(C) of this section;
14	(4) "Gift" means a gift of money or property; and
15	(5) "Institution" means a state-supported:
16	(A) Two-year institution of higher education; or
17	(B) Four-year institution of higher education.
18	
19	6-60-1203. Confucius Institutes — Certain affiliated entities —
20	Prohibited.
21	An institution shall not host:
22	(1) A Confucius Institute; or
23	(2) Any entity with an affiliation with:
24	(A) The People's Republic of China;
25	(B) The Chinese Communist Party; or
26	(C) China's People's Liberation Army.
27	
28	6-60-1204. Foreign gifts and contracts — Acceptance and disclosure.
29	(a) An institution shall not accept a gift from a foreign source or
30	enter into a contract with a foreign source if the institution believes that
31	doing so would threaten:
32	(1) The integrity of the institution's research, instruction, or
33	operations;
34	(2) The institution's intellectual property rights;
35	(3) The protection of confidential information; or
36	(4) The safety and security of:

1	(A) The institution;
2	(B) The institution's personnel and students;
3	(C) This state; or
4	(D) The United States.
5	(b) If an institution receives a gift from a foreign source valued at
6	more than ten thousand dollars ($\$10,000$), the institution shall disclose the
7	following information without limitation with respect to the gift:
8	(1) The dollar value of the gift;
9	(2) The name and national affiliation of the foreign source
10	funding the gift;
11	(3) The department, college, school, or other business unit of
12	the institution to which the gift was made;
13	(4) The date the gift was received; and
14	(5) A brief description of the gift.
15	(c) If an institution enters into a contract with a foreign source
16	valued at more than ten thousand dollars (\$10,000), the institution shall
17	disclose the following information without limitation with respect to the
18	<pre>contract:</pre>
19	(1) The dollar value of the contract;
20	(2) The name and national affiliation of the foreign source
21	entering into the contract with the institution;
22	(3) The department, college, school, or other business unit of
23	the institution that benefits from the contract;
24	(4) The effective date and termination date of the contract; and
25	(5) A brief description of the terms of the contract.
26	(d) If an institution receives multiple gifts from foreign sources
27	affiliated with the same foreign government and each of the gifts is valued
28	at ten thousand dollars (\$10,000) or less, but the aggregate value of the
29	gifts is more than ten thousand dollars (\$10,000) the institution shall
30	disclose each of the gifts as required under subsection (b) of this section.
31	(e) If an institution enters into multiple contracts with foreign
32	sources affiliated with the same foreign government and each of the contracts
33	is valued at ten thousand dollars (\$10,000) or less but the aggregate value
34	of the contracts is more than ten thousand dollars (\$10,000), the institution
35	shall disclose each of the contracts as required under subsection (c) of this
36	section.

2	6-60-1205. Gifts and contracts — Annual disclosure report.
3	(a) By July 31, 2021, and by July 31 of each year thereafter, each
4	institution shall prepare a gifts and contracts disclosure report that
5	includes the information required under § 6-60-1204 regarding gifts from
6	foreign sources and contracts entered into with foreign sources.
7	(b) The annual gifts and contracts disclosure report required under
8	subsection (a) of this section shall:
9	(1) Be submitted to the:
10	(A) Secretary of the Department of Finance and
11	Administration; and
12	(B) Department of Public Safety; and
13	(2) Disclose the gifts received from foreign sources and
14	contracts entered into with foreign sources during the fiscal year ending on
15	June 30 immediately preceding the reporting deadline under subsection (a) of
16	this section.
17	(c) If an institution does not have a gift or contract subject to the
18	disclosure reporting requirement under subsection (a) of this section, the
19	institution shall submit a gifts and contracts disclosure report stating that
20	the institution does not have a gift from a foreign source or a contract
21	entered into with a foreign source subject to disclosure.
22	(d) The secretary shall make the gifts and contracts disclosure
23	reports required under this section publicly available on the website of the
24	Department of Finance and Administration.
25	
26	SECTION 2. EMERGENCY CLAUSE. It is found and determined by the
27	General Assembly of the State of Arkansas that the Chinese Communist Party
28	has already been found to have placed spies in institutions of higher
29	education in this state; that it is necessary to preserve the state's
30	security and ensure transparency in the actions taken by state-supported
31	institutions of higher education; and that this act is immediately necessary
32	before the upcoming academic year in order to prohibit certain contracts and
33	gifts that may be entered into or received during the upcoming academic year.
34	Therefore, an emergency is declared to exist, and this act being immediately
35	necessary for the preservation of the public peace, health, and safety shall
36	hacoma affactiva on:

1	(1) The date of its approval by the Governor;
2	(2) If the bill is neither approved nor vetoed by the Governor,
3	the expiration of the period of time during which the Governor may veto the
4	bill; or
5	(3) If the bill is vetoed by the Governor and the veto is
6	overridden, the date the last house overrides the veto.
