27	WHEREAS, Arkansas Constitution, Article 6, § 19, provides that, after
28	the General Assembly has disposed of the business set forth in the Governor's
29	proclamation to convene an extraordinary session, the General Assembly may,
30	by a vote of two-thirds $(2/3)$ of all the members elected to both houses,
31	remain in session for a period not to exceed fifteen (15) days for the
32	purpose of transacting other legislative business; and

34	WHEREAS, the General Assembly has disposed of the matters set forth in
35	the Governor's proclamation calling the First Extraordinary Session of the
36	Ninety-Third General Assembly,

2	NOW THEREFORE,
3	BE IT RESOLVED BY THE SENATE OF THE NINETY-THIRD GENERAL ASSEMBLY OF THE
4	STATE OF ARKANSAS:
5	
6	THAT the First Extraordinary Session of the Ninety-Third General
7	Assembly has completed action deemed to be necessary with respect to the
8	business set forth in the Governor's proclamation to convene the
9	extraordinary session.
10	
11	BE IT FURTHER RESOLVED THAT the First Extraordinary Session of the
12	Ninety-Third General Assembly is extended in accordance with Arkansas
13	Constitution, Article 6, § 19, and shall remain in session for a period not
14	to exceed fifteen (15) days to consider one (1) or more bills to provide
15	protections for citizens by establishing rights to privacy, liability, or
16	other protections that are otherwise related to discrimination regarding
17	coronavirus 2019 (COVID-19) vaccines.
