## For An Act To Be Entitled

8 AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL  
9 SERVICES, OPERATING EXPENSES, EQUIPMENT AND GRANTS TO  
10 ARKANSAS DELTA TRAINING AND EDUCATION CONSORTIUM  
11 (ADTEC) PARTNERS AND UNIVERSITY CENTER PARTNERS OF  
12 THE ARKANSAS STATE UNIVERSITY - MID-SOUTH WHICH SHALL  
13 BE SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS  
14 APPROPRIATED BY ACT 115 OF 2021; AND FOR OTHER  
15 PURPOSES.

## Subtitle

18 AN ACT FOR THE ARKANSAS STATE UNIVERSITY  
19 - MID-SOUTH SUPPLEMENTAL APPROPRIATION.

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
24

25 SECTION 1. APPROPRIATION - ADTEC/UNIVERSITY CENTER PARTNERS. There is  
26 hereby appropriated, to the Arkansas State University - Mid-South, to be  
27 payable from the Arkansas State University Mid-South Fund, for personal  
28 services, operating expenses, equipment and grants to Arkansas Delta Training  
29 and Education Consortium (ADTEC) Partners and University Center Partners of  
30 the Arkansas State University - Mid-South which shall be supplemental and in  
31 addition to those funds appropriated in Section 5 of Act 115 of 2021, the

2 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
3 authorized by this act shall be limited to the appropriation for such agency  
4 and funds made available by law for the support of such appropriations; and  
5 the restrictions of the State Procurement Law, the General Accounting and  
6 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
7 Procedures and Restrictions Act, or their successors, and other fiscal  
8 control laws of this State, where applicable, and regulations promulgated by  
9 the Department of Finance and Administration, as authorized by law, shall be  
10 strictly complied with in disbursement of said funds.  
11

12 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General  
13 Assembly that any funds disbursed under the authority of the appropriations  
14 contained in this act shall be in compliance with the stated reasons for  
15 which this act was adopted, as evidenced by the Agency Requests, Executive  
16 Recommendations and Legislative Recommendations contained in the budget  
17 manuals prepared by the Department of Finance and Administration, letters, or  
18 summarized oral testimony in the official minutes of the Arkansas Legislative  
19 Council or Joint Budget Committee which relate to its passage and adoption.  
20

21 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General  
22 Assembly, that funds provided by the General Assembly for the operations of  
23 the Arkansas State University - Mid-South are, due to unforeseen  
24 circumstances, insufficient for the Arkansas State University - Mid-South to  
25 continue to provide essential governmental services; that the provisions of  
26 this act will provide the necessary monies for the Arkansas State University  
27 - Mid-South to continue such services; and that a delay in the effective date  
28 of this Act could work irreparable harm upon the proper administration and  
29 provision of essential governmental programs. Therefore, an emergency is  
30 hereby declared to exist and this Act being necessary for the immediate  
31 preservation of the public peace, health and safety shall be in full force  
32 and effect from and after the date of its passage and approval.

33 If the bill is neither approved nor vetoed by the Governor, it shall  
34 become effective on the expiration of the period of time during which the  
35 Governor may veto the bill. If the bill is vetoed by the Governor and the  
36 veto is overridden, it shall become effective on the date the last house

1 overrides the veto.
