SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 5 6 authorized by this act shall be limited to the appropriation for such agency 7 and funds made available by law for the support of such appropriations; and 8 the restrictions of the State Procurement Law, the General Accounting and 9 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal 10 11 control laws of this State, where applicable, and regulations promulgated by 12 the Department of Finance and Administration, as authorized by law, shall be 13 strictly complied with in disbursement of said funds.

15 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General 16 Assembly that any funds disbursed under the authority of the appropriations 17 contained in this act shall be in compliance with the stated reasons for 18 which this act was adopted, as evidenced by the Agency Requests, Executive 19 Recommendations and Legislative Recommendations contained in the budget 20 manuals prepared by the Department of Finance and Administration, letters, or 21 summarized oral testimony in the official minutes of the Arkansas Legislative 22 Council or Joint Budget Committee which relate to its passage and adoption. 23

24 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General 25 Assembly, that funds provided by the General Assembly for the operations of 26 the University of Arkansas Community College at Hope-Texarkana are, due to 27 unforeseen circumstances, insufficient for the University of Arkansas 28 Community College at Hope-Texarkana to continue to provide essential 29 governmental services; that the provisions of this act will provide the 30 necessary monies for the University of Arkansas Community College at Hope-Texarkana to continue such services; and that a delay in the effective date 31 32 of this Act could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is 33 34 hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force 35 36 and effect from and after the date of its passage and approval.
