12	HOUSE CONCURRENT RESOLUTION
13	TO AMEND THE JOINT RULES OF THE HOUSE OF
14	REPRESENTATIVES AND THE SENATE OF THE NINETY-THIRD
15	GENERAL ASSEMBLY; AND TO ESTABLISH A BILL-FILING
16	DEADLINE FOR LEGISLATION RELATED TO STATE ENTITY-
17	MANAGED HEALTH BENEFIT PLANS.

21	TO AMEND THE JOINT RULES OF THE HOUSE OF
22	REPRESENTATIVES AND THE SENATE OF THE
23	NINETY-THIRD GENERAL ASSEMBLY.

26	BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-THIRD GENERAL
27	ASSEMBLY OF THE STATE OF ARKANSAS, THE SENATE CONCURRING THEREIN:

29	SECTION 1. Section 14 of the Joint Rules of the House of
30	Representatives and the Senate of the Ninety-Third General Assembly,
31	concerning deadlines for the introduction of bills, is amended to read as
32	follows:
33	
34	Deadline for the Introduction of Bills
35	Section 14. (A) Appropriation Bills. An "appropriation bill" means a
36	bill by the General Assembly that authorizes the expenditure of moneys if

- 1 moneys are available.
- 2  $\frac{(B)}{(1)}$  No appropriation bill shall be filed for introduction in
- 3 either the House of Representatives or the Senate later than the fiftieth
- 4 (50th) day of a regular session except upon consent of two-thirds (2/3) of
- 5 the members elected to each house. When the filing deadline for any bills or
- 6 resolutions ends on Saturday or Sunday, the deadline is hereby extended until
- 7 the close of business the following Monday.
- 8 (2) Any proposed legislation affecting any publicly supported
- 9  $\frac{1}{1}$  retirement system or pension plan to be considered by the General Assembly at
- 10 a regular session shall be introduced in the General Assembly during the
- 11 first fifteen (15) calendar days of a regular session.
- 12 (3) No such bill shall be introduced after the fifteenth (15th)
- 13 day of a regular session unless its introduction is first approved by a
- 14 three-fourths (3/4) vote of the full membership of each house of the General
- 15 Assembly.
- 16  $\frac{(C)(1)}{(2)}$  No appropriation bill shall be filed for introduction
- 17 in either the House of Representatives or the Senate later than the fifteenth
- 18 (15th) day of a fiscal session except upon consent of two-thirds (2/3) of the
- 19 members elected to each house.
- 20 (B) Retirement System Legislation.
- 21 (1) Any proposed legislation affecting any publicly supported
- 22 retirement system or pension plan to be considered by the General Assembly at
- 23 a regular session shall be introduced in the General Assembly during the
- 24 first fifteen (15) calendar days of a regular session.
- 25 (2) No such bill shall be introduced after the fifteenth  $(15^{th})$
- 26 day of a regular session unless its introduction is first approved by a
- 27 three-fourths (3/4) vote of the full membership of each house of the General
- 28 Assembly.
- 29 (3) A bill affecting any publicly supported retirement system or
- 30 systems shall not be introduced at any special session of the General
- 31 Assembly unless the introduction and consideration of the bill is first
- 32 approved by a three-fourths (3/4) vote of the full membership of each house
- 33 of the General Assembly.
- 34 (C) Non-appropriation Legislation During a Fiscal Session.
- 35  $\frac{(2)(1)}{(2)}$  For a fiscal session, a non-appropriation bill shall not
- 36 be filed for introduction until identical resolutions authorizing the

- 1 introduction of the non-appropriation bill have been approved by an
- 2 affirmative vote of two-thirds (2/3) of the members elected to each house.
- 3  $\frac{(3)}{(2)}$  The identical resolutions authorizing the introduction of
- 4 a non-appropriation bill in a fiscal session shall not be filed for
- 5 introduction in either the House of Representatives or the Senate later than
- 6 the first  $(l^{st})$  day of a fiscal session.
- 7  $\frac{(4)(3)}{(4)}$  A non-appropriation bill shall not be filed for
- 8 introduction in either the House of Representatives or the Senate later than
- 9 the fifteenth (15th) day of a fiscal session.
- 10 (D) State and Public School Life and Health Insurance Program
- ll Legislation.
- 12 <u>(1) As used in this subsection (D):</u>
- (a) "Entity of the state" means any agency, board, bureau,
- 14 <u>commission</u>, committee, council, department, division, institution of higher
- 15 <u>education</u>, office, public school, quasi-public organization, or other
- 16 political subdivision of the state; and
- 17 (b) "Health benefit plan" means a policy, contract,
- 18 certificate, or agreement offered or issued by an entity to provide, deliver,
- 19 arrange for, pay for, or reimburse any of the costs of healthcare services,
- 20 <u>including pharmacy benefits</u>, to an entity of the state.
- 21 (2) A bill affecting the State and Public School Life and Health
- 22 Insurance Program or that imposes a new or increased cost obligation for
- 23 health benefit plans, including pharmacy benefits, on an entity of the state
- 24 to be considered by the General Assembly at a regular session shall be
- 25 <u>introduced in the General Assembly during the first fifteen (15) calendar</u>
- 26 days of a regular session.
- 27 (3) A bill as described in subsection (D)(2) shall not be
- 28 introduced after the fifteenth day of a regular session unless the
- 29 <u>introduction of the bill is first approved by a three-fourths (3/4) vote of</u>
- 30 the full membership of each house of the General Assembly.
- 31 (4) A bill affecting the State and Public School Life and Health
- 32 Insurance Program or that imposes a new or increased cost obligation for
- 33 <u>health benefit plans</u>, including pharmacy benefits, on an entity of the state
- 34 shall not be introduced or considered at a fiscal session or an extraordinary
- 35 <u>session of the General Assembly unless the introduction and consideration of</u>
- 36 the bill is first approved by a two-thirds (2/3) vote of the full membership

1	of each house of the General Assembly.
2	(E) When the filing deadline for any bills or resolutions ends on
3	Saturday or Sunday, the deadline is extended until the close of business the
4	following Monday.
5	(E) A bill affecting any publicly supported retirement system or
6	systems shall not be introduced or considered at any special session of the
7	General Assembly unless the introduction and consideration of the bill is
8	first approved by a three-fourths (3/4) vote of the full membership of each
9	house of the General Assembly.
10	(F) If the General Assembly recesses for longer than three (3)
11	consecutive days during the first fifteen (15) days of a regular session, the
12	fifteen-day introduction deadline deadlines established in this section shall
13	be extended for a time period equal to the recess.
