18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO.

21 There is hereby appropriated, to the Arkansas State University, to be payable
22 from the Development and Enhancement Fund, for the Arkansas State University
23 the following:

24 (A) Effective July 1, 2022, the balance of the appropriation provided
25 in Item (A) of Section 1 of Act 847 of 2021, for construction, renovation,
26 maintenance, equipment, personal services and operating expenses of the
27 various institutions and entities of the Arkansas State University System, in
28 a sum not to exceed\$15,000,000.

29 (B) Effective July 1, 2022, the balance of the appropriation provided
30 in Item (B) of Section 1 of Act 847 of 2021, for costs of construction of a
31 College of Engineering building, in a sum not to exceed\$4,364,480.

32 (C) Effective July 1, 2022, the balance of the appropriation provided
33 in Item (C) of Section 1 of Act 847 of 2021, for College of Education and
34 Communications restrooms renovation, in a sum not to exceed\$908,500.

35 (D) Effective July 1, 2022, the balance of the appropriation provided
36 in Item (D) of Section 1 of Act 847 of 2021, for Library HVAC system



1 renovation and modernization, in a sum not to exceed\$3,227,020.

2 (E) Effective July 1, 2022, the balance of the appropriation provided
3 in Item (E) of Section 1 of Act 847 of 2021, for critical maintenance, in a
4 sum not to exceed\$710,000.

5 (F) Effective July 1, 2022, the balance of the appropriation provided
6 in Item (F) of Section 1 of Act 847 of 2021, for deferred maintenance, in a
7 sum not to exceed\$2,870,000.

8 (G) Effective July 1, 2022, the balance of the appropriation provided
9 in Item (G) of Section 1 of Act 847 of 2021, for the purchase, replacement,

12 (H) Effective July 1, 2022, the balance of the appropriation provided

14 ASU System Enterprise Resource Program, in a sum not to exceed ...\$1,250,000.

16 SECTION 2. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO -
17 COGSWELL PORTRAIT CONSERVATION. There is hereby appropriated, to the
18 Arkansas State University, to be payable from the Arkansas Natural and
19 Cultural Resources Grant and Trust Fund, for the Arkansas State University
20 the following:

21 (A) Effective July 1, 2022, the balance of the appropriation provided
22 in Section 24 of Act 832 of 2021, for the acquisition, management,
23 stewardship, or preservation of state owned lands, historic sites, buildings,
24 structures, or objects, in a sum not to exceed\$14,000.
25

26 SECTION 3. REAPPROPRIATION - ARKANSAS STATE UNIVERSITY - JONESBORO -
27 PFEIFFER-JANES HOUSE ROOF REPAIR. There is hereby appropriated, to the
28 Arkansas State University, to be payable from the Arkansas Natural and
29 Cultural Resources Grant and Trust Fund, for the Arkansas State University
30 the following:

31 (A) Effective July 1, 2022, the balance of the appropriation provided
32 in Section 24 of Act 832 of 2021, for the acquisition, management,
33 stewardship, or preservation of state owned lands, historic sites, buildings,
34 structures, or objects, in a sum not to exceed\$22,950.

6 in Section 24 of Act 832 of 2021, for the acquisition, management,

24 Dean Hall, & Tucker Coliseum renovation, in a sum not to exceed ..\$4,765,200.

25 (B) Effective July 1, 2022, the balance of the appropriation provided
26 in Item (B) of Section 2 of Act 847 of 2021, for costs of construction of 0
27 Street closure and Campus Entrance, in a sum not to exceed\$2,330,000.

28 (C) Effective July 1, 2022, the balance of the appropriation provided
29 in Item (C) of Section 2 of Act 847 of 2021, for renovation for Brown
30 building academic utilization, in a sum not to exceed\$1,180,438.

31 (D) Effective July 1, 2022, the balance of the appropriation provided

SECTION 17. REAPPROPRIATION - UNIVERSITY OF ARKANSAS AT LITTLE ROCK -
SUSTAINABLE BUILDING DESIGN. There is hereby appropriated, to the University
of Arkansas at Little Rock, to be payable from the Sustainable Building
Design Revolving Loan Fund, for the University of Arkansas at Little Rock the
following:

(A) Effective July 1, 2022, the balance of the appropriation provided
in Item (A) of Section 21 of Act 181 of 2021, for construction, renovation,
maintenance and operating expenses, in a sum not to exceed\$1,000,000.

SECTION 18. REAPPROPRIATION - UNIVERSITY OF ARKANSAS - MONTICELLO.

There is hereby appropriated, to the University of Arkansas at Monticello, to be payable from the Development and Enhancement Fund, for the University of Arkansas at Monticello the following:

(A) Effective July 1, 2022, the balance of the appropriation provided in Item (A) of Section 9 of Act 847 of 2021, for costs of construction of a Math and Science Center, in a sum not to exceed\$4,750,000.

(B) Effective July 1, 2022, the balance of the appropriation provided in Item (B) of Section 9 of Act 847 of 2021, for renovation of the Fine Arts Center, in a sum not to exceed\$1,000,000.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 9 of Act 847 of 2021, for renovation of the Music Building, in a sum not to exceed\$750,000.

(D) Effective July 1, 2022, the balance of the appropriation provided in Item (D) of Section 9 of Act 847 of 2021, for costs of construction of the Workforce/Collegiate Center on the Crossett campus, in a sum not to exceed\$1,500,000.

(C) Effective July 1, 2022, the balance of the appropriation provided in Item (C) of Section 10 of Act 847 of 2021, for technology infrastructure upgrades, in a sum not to exceed\$605,000.

(D) Effective July 1, 2022, the balance of the appropriation provided in Item (D) of Section 10 of Act 847 of 2021, for critical maintenance, in a sum not to exceed\$490,000.

(E) Effective July 1, 2022, the balance of the appropriation provided in Item (E) of Section 10 of Act 847 of 2021, for deferred maintenance, in a sum not to exceed\$1,600,000.

30 SECTION 22. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor
31 obligations otherwise incurred in relation to the project or projects
32 described herein in excess of the State Treasury funds actually available
33 therefor as provided by law. Provided, however, that institutions and
34 agencies listed herein shall have the authority to accept and use grants and
35 donations including Federal funds, and to use its unobligated cash income or
36 funds, or both available to it, for the purpose of supplementing the State

1 Treasury funds for financing the entire costs of the project or projects
2 enumerated herein. Provided further, that the appropriations and funds
3 otherwise provided by the General Assembly for Maintenance and General
4 Operations of the agency or institutions receiving appropriation herein shall
5 not be used for any of the purposes as appropriated in this act.

6 (B) The restrictions of any applicable provisions of the State
7 Purchasing Law, the General Accounting and Budgetary Procedures Law, the
8 Revenue Stabilization Law and any other applicable fiscal control laws of
9 this State and regulations promulgated by the Department of Finance and
10 Administration, as authorized by law, shall be strictly complied with in
11 disbursement of any funds provided by this act unless specifically provided
12 otherwise by law.

14 SECTION 23. LEGISLATIVE INTENT. It is the intent of the General
15 Assembly that any funds disbursed under the authority of the appropriations
16 contained in this act shall be in compliance with the stated reasons for
17 which this act was adopted, as evidenced by the Agency Requests, Executive
18 Recommendations and Legislative Recommendations contained in the budget
19 manuals prepared by the Department of Finance and Administration, letters, or
20 summarized oral testimony in the official minutes of the Arkansas Legislative
21 Council or Joint Budget Committee which relate to its passage and adoption.

23 SECTION 24. EFFECTIVE DATE. This act is effective on and after July 1,
24 2022.
