2	by the House of Representatives and the Senate;
3	(c) That under Arkansas Constitution, Article 6, § 15, before
4	adjournment of the General Assembly, the Governor is afforded five (5) days
5	after receipt of a bill to sign a bill or veto a bill; therefore, the House
6	of Representatives and the Senate shall be open on regular business days
7	through 12:00 noon, March 30, 2022, so that the office of the Chief Clerk of
8	the House of Representatives and the office of the Secretary of the Senate
9	may receive communications, vetoes of bills by the Governor, and notification
10	of errors and oversights;
11	(d) That the Speaker of the House of Representatives and the President
12	Pro Tempore of the Senate may, by joint proclamation:
13	(1) Reconvene the General Assembly at any time before 12:00
14	noon, March 30, 2022, for the purpose of:
15	(A) Considering vetoes; or
16	(B) Correcting errors and oversights; or
17	(2) Adjourn the Fiscal Session of the Ninety-Third General
18	Assembly at any time before 12:00 noon, March 30, 2022, if they determine it
19	is not necessary to reconvene; and
20	(e) That if the General Assembly is not reconvened or adjourned before
21	12:00 noon, March 30, 2022, the Fiscal Session of the Ninety-Third General
22	Assembly is adjourned sine die on that date.
