29 SECTION 2. EXTRA HELP. There is hereby authorized, for the Department 30 of Finance and Administration - Child Support Enforcement for the 2023-2024 31 fiscal year, the following maximum number of part-time or temporary 32 employees, to be known as "Extra Help", payable from funds appropriated 33 herein for such purposes: fifteen (15) temporary or part-time employees, 34 when needed, at rates of pay not to exceed those provided in the Uniform 35 Classification and Compensation Act, or its successor, or this act for the 36 appropriate classification.

2 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated, 3 to the Department of Finance and Administration, to be payable from the Child 4 Support Enforcement Fund, for personal services and operating expenses of the 5 Department of Finance and Administration - Child Support Enforcement for the 6 fiscal year ending June 30, 2024, the following:

SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS 22 23 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. EXTRA 24 HELP EXEMPTION. Extra Help positions authorized herein are specifically 25 exempt from limitation of hours, either by act or regulation. Provided, 26 however, when a temporary or part-time employee is employed by the Department 27 of Finance and Administration - Office of Child Support Enforcement for a 28 period of time exceeding seven (7) months, a report of such shall be filed 29 with the Legislative Council or Joint Budget Committee.

The provisions of this section shall be in effect only from July 1, 2022
2023 through June 30, 2023 2024.

33 SECTION 5. COMPLIANCE WITH OTHER LAWS. Disbursement of funds 34 authorized by this act shall be limited to the appropriation for such agency 35 and funds made available by law for the support of such appropriations; and 36 the restrictions of the State Procurement Law, the General Accounting and

Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 Procedures and Restrictions Act, or their successors, and other fiscal
 control laws of this State, where applicable, and regulations promulgated by
 the Department of Finance and Administration, as authorized by law, shall be
 strictly complied with in disbursement of said funds.

7 SECTION 6. LEGISLATIVE INTENT. It is the intent of the General 8 Assembly that any funds disbursed under the authority of the appropriations 9 contained in this act shall be in compliance with the stated reasons for 10 which this act was adopted, as evidenced by the Agency Requests, Executive 11 Recommendations and Legislative Recommendations contained in the budget 12 manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative 13 14 Council or Joint Budget Committee which relate to its passage and adoption. 15

16 SECTION 7. EMERGENCY CLAUSE. It is found and determined by the General 17 Assembly, that the Constitution of the State of Arkansas prohibits the 18 appropriation of funds for more than a one (1) year period; that the 19 effectiveness of this Act on July 1, 2023 is essential to the operation of 20 the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the 21 22 effective date of this Act beyond July 1, 2023 could work irreparable harm 23 upon the proper administration and provision of essential governmental 24 programs. Therefore, an emergency is hereby declared to exist and this Act 25 being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2023. 26 27 28 29 30 31 32 33
