     TRANSFER OF FUNDS - PROMOTIONAL ITEMS. The Chief Fiscal Officer of the State

     shall establish upon request from the Arkansas Department of Education -

     Arkansas State Library a special appropriation line item to be used in the

     acquisition of promotional items. When the Department of Education -

     Arkansas State Library wishes to transfer monies from its operating expenses

     to promotional items, the request shall be forwarded to the Chief Fiscal
