23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25 SECTION 1. Arkansas Code § 6-18-203(a), concerning a student's
26 eligibility to attend a school district when he or she resides on a tract of
27 land located in two (2) school districts, is amended to read as follows:

28 ~~(a)(1) Except as provided in subdivision (a)(2) of this section, when~~
29 ~~any~~ When a person owns a tract of land on which the person resides and which
30 ~~tract of land that~~ is located partially in one (1) school district and
31 partially in another school district, the school-age children of that person
32 ~~shall attend school in the school district where the residence is located.~~

33 ~~(2) When a person owned an undivided tract of land on which that~~
34 ~~person domiciled for ten (10) or more years before August 13, 2001, and which~~
35 ~~undivided tract of land is located partially in one (1) school district and~~
36 ~~partially in another, the school-age children of that person, and those of~~



1 his or her successors in title, ~~shall be~~ are eligible to attend the school in
2 either of the school districts regardless of the location of the home on the
3 ~~property~~ tract of land on which the person resides.
