16	(B) The playing of abusive or truculent tricks on or off	
17	the property or training environments of the Arkansas Law Enforcement	
18	Training Academy by a student, instructor, or employee of the academy, acting	
19	alone, or acting with others, upon another person to frighten or scare him or	
20	<u>her.</u>	
21	(2) "Hazing" is limited to those actions taken and situations	
22	created in connection with education or affiliation with the academy; and	
23	(3) "Hazing does not include customary athletic events or	
24	similar contests or competitions.	
25	(b)(1) All instructors and employees responsible for training, or who	
26	are assigned a position of authority in the academy, shall complete annual	
27	training concerning hazing and the prevention of hazing at the academy.	
28	(2) All training materials under subdivision (b)(1) of this	
29	section shall be approved by the Arkansas Commission on Law Enforcement	
30	Standards and Training.	
31	(c) A student, instructor, or employee of the academy shall not	
32	knowingly engage in hazing or encourage, aid, or assist any other student,	
33	instructor, or employee in hazing.	
34	(d) A person shall not knowingly permit, encourage, aid, or assist	
35	another person in hazing, or knowingly acquiesce to hazing, or fail to report	
36	promptly his or her knowledge or any reasonable information within his or her	

1	knowledge of the presence and practice of hazing to the Secretary of the		
2	Department of Public Safety for investigation.		
3	(e) A violation this section is a:		
4	(1) Class D felony if the actor is an instructor or employee of		
5	the academy and the actor:		
6	(A) Allows or participates in the hazing of a student of		
7	the academy;		
8	(B) The hazing causes physical injury to the student; or		
9	(2) Class B misdemeanor if otherwise committed.		
10	(f) In addition to any penalty provided by this section:		
11	(1) A student convicted under this section shall be expelled		
12	from the academy; and		
13	(2) An instructor or employee of the academy convicted under		
14	this section shall be terminated from employment with the academy.
