2	and future effect that implements, interprets, or prescribes law or policy or
3	describes the organization, procedure, or practice of an agency pertaining to
4	milk and cattle production, but not including other rules pertaining solely
5	to waste management, including without limitation the amendment or repeal of
6	a prior rule.
7	(B) "Rule" does not mean:
8	(i) A statement that concerns the internal management
9	of an agency and that does not affect the private rights or procedures
10	available to the public;

18	(a)(1) By December 1, 2021, each agency that has promulgated rules
19	pertaining to milk and cattle production, but not including other rules
20	pertaining solely to waste management, shall file an initial rule report with
21	the Governor and the Legislative Council.
22	(2)(A) The initial rule report shall contain a list of all the
23	rules in effect promulgated by the agency that pertain to milk and cattle
24	production, but not including other rules pertaining solely to waste
25	management.
26	(B) The list of rules under subdivision (a)(2)(A) of this
27	section shall include:
28	(i) The initial effective date of each rule;
29	(ii) The date that each rule was filed with the
30	Secretary of State;
31	(iii) The authority under which each rule was
32	promulgated; and
33	(iv) If the rule is required under state or federal
34	law, a statement regarding the requirement.

1	(2) An updated final rule report shall include the date the rule
2	was filed, amended, or repealed during the interim.
3	(e)(1) Upon receipt of the recommendations of the House Committee on
4	Agriculture, Forestry, and Economic Development and the Senate Committee on
5	Agriculture, Forestry, and Economic Development, the Legislative Council
6	shall vote no later than December 31, 2022, to determine whether each rule
7	shall:
8	(A) Continue to remain in effect; or
9	(B) Be repealed.
10	(2) If the Legislative Council votes to repeal a rule, the rule
11	shall sunset after December 31, 2022.

13	SECTION 2. Arkansas Code § 25-16-903(11), concerning state boards
14	authorized to receive stipends not to exceed sixty dollars (\$60.00) per day,

20	SECTION 3. DO NOT CODIFY. CONSTRUCTION AND LEGISLATIVE INTENT.
21	It is the intent of the General Assembly that:
22	(1) The enactment and adoption of this act shall not expressly
23	or impliedly repeal an act passed during the regular session of the Ninety-
24	Fourth General Assembly;
25	(2) To the extent that a conflict exists between an act of the
26	regular session of the Ninety-Fourth General Assembly and this act:
27	(A) The act of the regular session of the Ninety-Fourth
28	General Assembly shall be treated as a subsequent act passed by the General
29	Assembly for the purposes of:
30	(i) Giving the act of the regular session of the
31	Ninety-Fourth General Assembly its full force and effect; and
32	(ii) Amending or repealing the appropriate parts of
33	the Arkansas Code of 1987; and
34	(B) Section 1-2-107 shall not apply; and
35	(3) This act shall make only technical, not substantive, changes
36	to the Arkansas Code of 1987.
