19	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20	
21	SECTION 1. Arkansas Code Title 6, Chapter 16, Subchapter 1, is amended
22	to add an additional section to read as follows:
23	6-16-156. Agricultural education.
24	(a)(1) Beginning with the 2025-2026 school year, the Division of
25	Elementary and Secondary Education may consult industry stakeholders,
26	including without limitation the Department of Agriculture and the Arkansas
27	Farm Bureau Federation in order to establish a pilot program to provide for
28	agricultural education in elementary schools in the State of Arkansas.
29	(2) The pilot program required by this section may determine
30	whether and how to implement an elementary agricultural education program
31	statewide.
32	(b)(1) The division, in consultation with the Arkansas Farm Bureau
33	Federation and department, may select via an application process a minimum of
34	six (6) elementary schools for participation in the pilot program established
35	by this section.
36	(2) The local school district board of directors for each of the

1	elementary schools selected under subdivision (b)(1) of this section shall
2	agree to:
3	(A) Implement an elementary agricultural education program
4	in its public school district for a minimum of three (3) years;
5	(B) Continue to provide elementary agricultural education
6	until the pilot program is either:
7	(i) Implemented in public elementary schools
8	statewide; or
9	(ii) Terminated by the division, in consultation
10	with the Arkansas Farm Bureau Federation and the department; and
11	(C) Determine the method by which an elementary
12	agricultural education program shall be implemented in the public school
13	district.
14	(3) The local school district board of directors for each of the
15	elementary schools selected under subdivision (b)(1) of this section may
16	employ an agricultural education teacher to provide the agricultural
17	education program at its public school district.
18	(c) The pilot program shall be based on the nationally recognized
19	three-component model of school-based agricultural education, which includes
20	without limitation:
21	(1) Instruction in an organized classroom or laboratory
22	<u>environment;</u>
23	(2) Hands-on, real-world learning opportunities; and
24	(3) Leadership and learning opportunities through participation
25	in the Arkansas Division of the Future Farmers of America and an Arkansas 4-H
26	Foundation, Incorporated program.
27	(d) The curriculum for the elementary agricultural education program
28	shall be fact-based instruction that shall:
29	(1) Include without limitation equal portions of each of the
30	three (3) components of school-based agricultural education, as specified
31	under subsection (c) of this section;
32	(2) Provide grade-appropriate, collaborative learning
33	experiences through:
34	(A) Instruction and inquiry;
35	(B) Experimental learning activities; and
36	(C) Personal and leadership development opportunities; and

1	(3) Be established by the division, in consultation with the
2	Arkansas Farm Bureau Federation and department, with input from agricultural
3	and general education teachers.
4	(e) The division, in consultation with the Arkansas Farm Bureau
5	Federation and department, may:
6	(1) Provide for a program evaluation regarding the success and
7	impact of the pilot program established by this section upon completion of
8	the third year of the pilot program; and
9	(2) Report the results of the evaluation required by subdivision
10	(e)(1) of this section to the:
11	(A) House Committee on Education;
12	(B) Senate Committee on Education; and
13	(C) State Board of Education.
