SECTION 2. Arkansas Code  $\S$  26-35-1004 is amended to read as follows: 26-35-1004. Tax receipt form.

The Upon request by the person paying taxes, the county collector, whenever any taxes are paid, shall give the person paying them taxes a receipt dated, numbered, and filled out so as to show by whom, on what, and amount of taxes paid, amount of land and personalty, and percentage rate at the foot of the receipts. The receipt shall be prepared for the purpose and, in case of land, distinctly specify it as it is described on the tax books. The receipt may be in the following form:
