25	scrap metal, is amended to read a	s follows:	
26	(7) <u>(A)</u> "Scrap metal"	means bits and piece	s of metal parts that <u>:</u>
27	<u>(i)</u> may <u>M</u>	ay be combined togeth	er with bolts or
28	soldering; and		
29	<u>(ii)</u>	<u>Can</u> be recycled when	worn or superfluous <u>.</u>
30	<u>(B)</u> "Scrap met	al" includes detached	catalytic converters;

32	SECTION 2. Arkansas Code §	17-44-102, concernin	g the required records
33	of scrap metal recyclers, is amended to add an additional subsection to read		
34	as follows:		
35	<u>(i)(l) A scrap metal recyc</u>	ler purchasing one (1	<u>) or more catalytic</u>
36	converters from a seller shall:

1	(A) Issue payment to the seller for one (1) or more		
2	catalytic converters by mailing a nontransferable check, made payable to the		
3	seller, for the amount of the transaction to the street address or post		
4	office box provided by the seller under subdivision (d)(l) of this section;		
5	and		
6	(B) Issue the check five (5) days after the date of the		
7	transaction.		
8	(2) A seller may request the reissuance of a check from the		
9	scrap metal recycler pursuant to a transaction under subdivision (i)(l) of		
10	this section if:		
11	(A) The check is:		
12	(i) Not received within twenty (20) days of the		
13	transaction by the seller; or		
14	(ii) Returned as undelivered or undeliverable and		
15	the seller provides a corrected address for the transaction record under		
16	subdivision (d)(1) of this section;		
17	(B) The check has not been cashed or deposited into an		
18	account; and		
19	(C) No law enforcement agency has contacted the scrap		
20	metal recycler regarding the transaction.

22	SECTION 3. Arkansas Code § 17-44-109(a)(1), concerning a buyer of used		
23	catalytic converters, is amended to read as follows:		
24	(a)(l) A buyer of a used catalytic converter other than a scrap metal		
25	recycler shall file an electronic record of the used catalytic converter		
26	purchase.		
27			
28	SECTION 4. Arkansas Code § 17-44-109(b), concerning a buyer of used		
29	catalytic converters, is amended to read as follows:		
30	(b) The buyer of a used catalytic converter other than a scrap metal		
31	recycler :		
32	(1) Shall maintain a receipt of the electronic record entry as a		
33	record of the purchase of a used catalytic converter; and		
34	(2) Is subject to the penalties under § 17-44-102(f)(2)(B) for		
35	failure to file an electronic report of the purchase of a used catalytic		
36	converter.

2	SECTION 5. Arkansas Code § 17-44-109(e)(1), concerning a buyer of used		
3	catalytic converters, is amended to read as follows:		
4	(e)(l) A buyer of a used catalytic converter other than a scrap metal		
5	recycler must shall be registered with the county sheriff.

7	SECTION 6. Arkansas Code § 17-44-109, concerning a buyer of used		
8	catalytic converters, is amended to add an additional subsection to read as		
9	follows:		
10	(g)(1) A buyer of used catalytic converters shall:		
11	(A) Issue payment to the seller for one (1) or more		
12	catalytic converters by mailing a nontransferable check, made payable to the		
13	seller, for the amount of the transaction to the street address or post		
14	office box provided by the seller under subdivision (a)(4)(B) of this		
15	section; and		
16	(B) Issue the check five (5) days after the date of the		
17	transaction.		
18	(2) A seller may request the reissuance of a check from the		
19	buyer pursuant to a transaction under subdivision (g)(1) of this section if:		
20	(A) The check is:		
21	(i) Not received within twenty (20) days of the		
22	transaction by the seller; or		
23	(ii) Returned as undelivered or undeliverable and		
24	the seller provides a corrected address for the transaction record under		
25	<pre>subdivision (a)(4)(B) of this section;</pre>		
26	(B) The check has not been cashed or deposited into an		
27	account; and		
28	(C) No law enforcement agency has contacted the buyer		
29	regarding the transaction.
