28	SECTION 2. Arkansa	s Code § 19-5-303(s), concern	ning funds of
29	institutions of higher ed	ucation, is amended to read a	as follows:
30	(s) South Arkansas	Community College Fund.	
31	(1) There is	established on the books of	the Treasurer of State,
32	the Auditor of State, and the Chief Fiscal Officer of the State a fund to be		
33	known as the "South Arkansas <del>Community</del> College Fund".		
34	(2) The Sout	h Arkansas <del>Community</del> College	Fund shall be used for
35	the maintenance, operation	n, and improvement of South A	Arkansas <del>Community</del>
36	College.

1	(3) The South Arkansas <del>Community</del> College Fund shall consist of:		
2	(A) Those general revenues as may be provided by law; and		
3	(B) Any other funds made available for the support of		
4	South Arkansas Community College, which are required to be deposited into the		
5	State Treasury by law.

7	SECTION 3. Arkansas Code § 19-11-220(a)(33), concerning state agencies		
8	authorized to have an agency procurement official, is amended to read as		
9	follows:		
10	(33) South Arkansas <del>Community</del> College;		
11			
12	SECTION 4. EMERGENCY CLAUSE. It is found and determined by the		
13	General Assembly of the State of Arkansas that there are a number of		
14	requirements a college must meet in order to change its official name; and it		
15	is important to begin the process of changing a college's official name and		
16	designation as soon as practicable with all relevant state and federal		
17	agencies and businesses. Therefore, an emergency is declared to exist, and		
18	this act being immediately necessary for the preservation of the public		
19	peace, health, and safety shall become effective on:		
20	(1) The date of its approval by the Governor;		
21	(2) If the bill is neither approved nor vetoed by the Governor,		
22	the expiration of the period of time during which the Governor may veto the		
23	bill; or		
24	(3) If the bill is vetoed by the Governor and the veto is		
25	overridden, the date the last house overrides the veto.
