3	(a) Notwithstanding any other law, the following may not purchase or		
4	acquire title to agricultural land in this state:		
5	(1) A governmental entity of the People's Republic of China; or		
6	(2) A company or other entity:		
7	(A) That is headquartered in the People's Republic of

9	(B) That is directly or indirectly held or controlled by

11	(b) This section applies only to the purchase of or other acquisition		
12	of title to agricultural land on or after the effective date of this act.		
13	(c) A transfer of an interest in agricultural land in violation of
