12	SECTION 2. Arkansas Code Title 27, Chapter 24, Subchapter 14, is		
13	amended to add an additional section to read as follows:		
14	27-24-1431. Little Rock Central High School National Historic Site		
15	special license plate.		
16	(a) The Secretary of the Department of Finance and Administration		
17	shall create and issue a Little Rock Central High School National Historic		
18	Site special license plate in the manner provided for in this section.		
19	(b) The Little Rock Central High School National Historic Site special		
20	license plate shall be:		
21	(1) Designed by the Department of Finance and Administration in		
22	consultation with The Tiger Foundation; and		
23	(2) Numbered consecutively.		
24	(c) The procedures concerning costs for issuance under § 27-24-		
25	1404(c)(1)(A) shall apply.		
26	(d) The Department of Finance and Administration shall issue a special		
27	license plate under this section upon payment of:		
28	(1) The fee required by law for registration of the motor		
29	vehicle;		
30	(2)(A) Twenty-five dollars (\$25.00) to cover the design-use		
31	contribution.		
32	(B) The design-use contribution under subdivision		
33	(b)(2)(A) of this section shall be remitted monthly to The Tiger Foundation		
34	to be used to broaden the support and resources for Little Rock Central High		
35	School with a focus on academics, the arts, citizenship, and athletics; and		
36	(3(A) A handling and administrative fee of ten dollars (\$10.00).		

1	(B) The handling and administrative fee under subdivision		
2	(b)(3)(A) of the section shall be:		
3	(i) Deposited into the State Central Services Fund		
4	for the benefit of the Revenue Division; and		
5	(ii) Credited to the division as supplemental and in		
6	addition to all other funds that may be deposited for the benefit of the		
7	division.		
8	(C) The handling and administrative fee under subdivision		
9	(b)(3)(A) of this section shall not be considered or credited to the division		
10	as direct revenue.		
11	(d)(1) A special license plate issued under this subchapter may be		
12	renewed annually or replaced under the procedures set out in § 27-24-1405.		
13	(2) However, the division shall remit the fees collected under §		
14	27-24-1405(b)(2) on a monthly basis to The Tiger Foundation.
