construction entity, after providing agency services during the preconstruction period, serves as the general contractor and the following conditions are met: (i) The construction manager provides a maximum guaranteed price; (ii) The public school district political subdivision holds all trade contracts and purchase orders; and (iii) The portion of the project not covered by the trade contracts is bonded and guaranteed by the construction manager; and (C)(i) "General contractor construction management", in which the construction entity, after providing agency services during the preconstruction period, serves as the general contractor. (ii) The general contractor shall hold all trade contracts and purchase orders and shall bond and guarantee the project. SECTION 2. Arkansas Code § 19-11-801(e)(1), concerning the definitions used in relation to the procurement of professional services, is amended to read as follows: (1) "Political subdivision" means counties, school districts, cities of the first class, cities of the second class, and incorporated towns, and all other bodies politic; and
