Arkansas Code § 15-42-104, concerning hunting and fishing 30 licenses for residents, is amended to add subsection (f) to read as follows: 31 (f)(1) When a resident purchases a license, permit, or stamp with an approved credit card, debit card, or other electronic payment method, the 32 33 commission may assess a transaction fee not to exceed the fee the payment processor charges the commission for allowing the commission to accept the 34 35 approved credit card, debit card, or other electronic payment method as the

resident's payment for the license, permit, or stamp.
