2	14-59-116. Annual publication of financial statement.		
3	(a)(l) The governing body of each municipality shall publish annually		
4	a financial statement of the municipality, including receipts and		
5	expenditures for the period and a statement of the indebtedness and financial		
6	condition of the municipality. The financial statement shall be published:		
7	(A) By all municipalities one (1) time in a newspaper		
8	published in the municipality; and		
9	(B) By a city of the first class or a city of the second		
10	class on a website or social media page owned or maintained by the city.		
11	(2) This financial statement shall be at least as detailed as		
12	the minimum record of accounts as provided in this chapter.		
13	(3) This financial statement shall be published by April 1 of		
14	the following year.		
15	(b) <u>(l) In Except as provided in subdivision (b)(2) of this section, in</u>		
16	municipalities in which no newspaper is published, the financial statement		
17	shall be posted in two (2) of the most public places in the municipality.
