4	raffle tickets, is amended to read as follows:		
5	(c) <del>(1)</del> All Except as provided in § 23-114-401(b)(2)(C):		
6	(1) All bingo faces and raffle tickets shall be preprinted on		
7	paper or plastic+; and		
8	(2) Electronic devices, machines, or facsimiles shall not be		
9	used as bingo faces, raffle tickets, or otherwise, by participants of games		
10	of bingo or raffles conducted under this chapter.		
11			
12	SECTION 4. Arkansas Code § 23-114-401(b)(2) and (3), concerning how		
13	raffle tickets are sold, is amended to read as follows:		
14	(2) Raffle tickets may be sold:		
15	(A) At the authorized premises of the licensed authorized		
16	organization; and		
17	(B) Off the authorized premises of the licensed authorized		
18	organization if the tickets are sold by uncompensated volunteers of the		
19	licensed authorized organization; and		
20	(C) Through the mail, internet, email, fax, telephone, or		
21	any other electronic means by the licensed authorized organization or by		
22	uncompensated volunteers of the licensed authorized organization.		
23	(3) No raffle ticket shall be sold through the mail or through		
24	the Internet, email, fax, telephone, or any other electronic means.
