23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. REGULAR SALARIES - STATEWIDE SHARED SERVICES - EMPLOYEE
26 BENEFITS DIVISION. There is hereby established for the Department of
27 Transformation and Shared Services - Statewide Shared Services - Employee
28 Benefits Division for the 2023-2024 fiscal year, the following maximum number
29 of regular employees.

17 SECTION 2. EXTRA HELP. There is hereby authorized, for the Department
 18 of Transformation and Shared Services - Statewide Shared Services - Employee
 19 Benefits Division for the 2023-2024 fiscal year, the following maximum number
 20 of part-time or temporary employees, to be known as "Extra Help", payable
 21 from funds appropriated herein for such purposes: three (3) temporary or
 22 part-time employees, when needed, at rates of pay not to exceed those
 23 provided in the Uniform Classification and Compensation Act, or its
 24 successor, or this act for the appropriate classification.

26 SECTION 3. APPROPRIATION - STATEWIDE SHARED SERVICES - EMPLOYEE
 27 BENEFITS DIVISION OPERATIONS. There is hereby appropriated, to the
 28 Department of Transformation and Shared Services, to be payable from the
 29 State Central Services Fund, for personal services and operating expenses of
 30 the Department of Transformation and Shared Services - Statewide Shared
 31 Services - Employee Benefits Division - Operations for the fiscal year ending
 32 June 30, 2024, the following:

28 SECTION 5. APPROPRIATION - STATEWIDE SHARED SERVICES - EMPLOYEE

29 BENEFITS DIVISION - MISCELLANEOUS CASH. There is hereby appropriated, to the
 30 Department of Transformation and Shared Services, to be payable from the cash
 31 fund deposited in the State Treasury as determined by the Chief Fiscal
 32 Officer of the State, for personal services and operating expenses of the
 33 Department of Transformation and Shared Services - Statewide Shared Services
 34 - Employee Benefits Division - Miscellaneous Cash for the fiscal year ending
 35 June 30, 2024, the following:

15 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
 16 authorized by this act shall be limited to the appropriation for such agency
 17 and funds made available by law for the support of such appropriations; and
 18 the restrictions of the State Procurement Law, the General Accounting and
 19 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
 20 Procedures and Restrictions Act, or their successors, and other fiscal
 21 control laws of this State, where applicable, and regulations promulgated by
 22 the Department of Finance and Administration, as authorized by law, shall be
 23 strictly complied with in disbursement of said funds.

25 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General
 26 Assembly that any funds disbursed under the authority of the appropriations
 27 contained in this act shall be in compliance with the stated reasons for
 28 which this act was adopted, as evidenced by the Agency Requests, Executive
 29 Recommendations and Legislative Recommendations contained in the budget
 30 manuals prepared by the Department of Finance and Administration, letters, or
 31 summarized oral testimony in the official minutes of the Arkansas Legislative
 32 Council or Joint Budget Committee which relate to its passage and adoption.

33

34 SECTION 8. EMERGENCY CLAUSE. It is found and determined by the General
 35 Assembly, that the Constitution of the State of Arkansas prohibits the
 36 appropriation of funds for more than a one (1) year period; that the

1 effectiveness of this Act on July 1, 2023 is essential to the operation of
2 the agency for which the appropriations in this Act are provided, and that in
3 the event of an extension of the legislative session, the delay in the
4 effective date of this Act beyond July 1, 2023 could work irreparable harm
5 upon the proper administration and provision of essential governmental
6 programs. Therefore, an emergency is hereby declared to exist and this Act
7 being necessary for the immediate preservation of the public peace, health
8 and safety shall be in full force and effect from and after July 1, 2023.
