27 SECTION 51. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS  
29 STATE BOARD OF NURSING - FUNDING TRANSFER. The Arkansas State Board of  
30 Nursing may request a fund transfer in an amount not to exceed one hundred  
31 thousand dollars (\$100,000) each fiscal year from the State Board of Nursing  
32 Fund to the cash in State Treasury fund as determined by the Chief Fiscal  
33 Officer of the State to provide funds for the Student Loan Program  
34 appropriation provided herein. Upon approval of the Chief Fiscal Officer of  
35 the State, the amount requested shall be transferred on his or her books and  
36 those of the State Treasurer and the Auditor of State.

11 (2) An outside investigator contacted under subdivision (a)(1) of  
12 this section shall have expertise or background in the subject matter in  
13 which he or she is being contracted to investigate.

14 (b) The duties of an investigator hired under this section shall  
15 include without limitation investigation and inspection of all complaints, as  
16 determined by the board, to determine whether a person has:

17 (1) Practiced his or her profession in such a way as to endanger  
18 the general health and welfare of the public; or

19 (2) Otherwise violated this chapter or rules of the board.

20 (c)(1) The board shall file a report annually on or before December 1 with  
21 the Senate Committee on State Agencies and Governmental Affairs and the House  
22 Committee on State Agencies and Governmental Affairs for the committees'  
23 review.

24 (2) The report shall include:

25 (A) The number of complaints that have been filed;

26 (B) A list of who has been investigated and the purported  
27 violation; and

28 (C) A summary of the findings of each investigation.

32 ARKANSAS SPINAL CORD COMMISSION - LINE ITEM TRANSFER. Any savings made in the  
33 State Appropriation may, after receiving advice and approval of the  
34 Department of Finance and Administration, be transferred to the Spinal  
35 Treatment Program.

36 The provisions of this section shall be in effect only from July 1, ~~2022~~

3 SECTION 54. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
4 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS  
5 STATE BOARD OF DENTAL EXAMINERS - EDUCATIONAL PROGRAMS. The Arkansas State  
6 Board of Dental Examiners is hereby authorized to expend from monies  
7 authorized herein, \$15 from each licensed dentist licensed by the State Board  
8 of Dental Examiners each year to be paid by the Arkansas State Board of  
9 Dental Examiners to 501(c)(3) Arkansas foundations that have healthcare  
10 professionals on their board and provide for identification, treatment and  
11 monitoring of healthcare professionals who suffer from alcohol or drug abuse  
12 problems, in order to promote the public health and safety and to insure the  
13 continued availability of skilled and highly trained dental professionals for  
14 the benefit of the public.

15 The provisions of this section shall be in effect only from July 1, 2023  
16 through June 30, 2024.

18 SECTION 55. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
19 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. ARKANSAS  
20 BOARD OF PODIATRIC MEDICINE - EDUCATIONAL PROGRAMS. The Arkansas Board of  
21 Podiatric Medicine is hereby authorized to expend from monies authorized  
22 herein, \$10 from each licensed podiatrist licensed by the Arkansas Board of  
23 Podiatric Medicine each year to be paid by the Arkansas Board of Podiatric  
24 Medicine to 501(c)(3) Arkansas foundations that have healthcare professionals  
25 on their board and provide for identification, treatment and monitoring of  
26 healthcare professionals who suffer from alcohol or drug abuse problems, in  
27 order to promote the public health and safety and to insure the continued  
28 availability of skilled and highly trained podiatric professionals for the  
29 benefit of the public.

30 The provisions of this section shall be in effect only from July 1, 2023  
31 through June 30, 2024."

32  
33 SECTION 56. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS  
34 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER  
35 OF FUNDS. Immediately upon the effective date of this act, the Arkansas State  
36 Medical Board shall transfer the sum of five hundred thousand dollars

1 (\$500,000) from the Arkansas State Medical Board's cash funds to the  
2 Department of Education - Division of Higher Education's Graduate Medical  
3 Education Fund to be used exclusively for the Graduate Medical Education  
4 Residency Expansion Board appropriation.

5 The provisions of this section shall be in effect only from July 1, 2023  
6 through June 30, 2024.

8 SECTION 57. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
9 authorized by this act shall be limited to the appropriation for such agency  
10 and funds made available by law for the support of such appropriations; and  
11 the restrictions of the State Procurement Law, the General Accounting and  
12 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
13 Procedures and Restrictions Act, or their successors, and other fiscal  
14 control laws of this State, where applicable, and regulations promulgated by  
15 the Department of Finance and Administration, as authorized by law, shall be  
16 strictly complied with in disbursement of said funds.

18 SECTION 58. LEGISLATIVE INTENT. It is the intent of the General  
19 Assembly that any funds disbursed under the authority of the appropriations  
20 contained in this act shall be in compliance with the stated reasons for  
21 which this act was adopted, as evidenced by the Agency Requests, Executive  
22 Recommendations and Legislative Recommendations contained in the budget  
23 manuals prepared by the Department of Finance and Administration, letters, or  
24 summarized oral testimony in the official minutes of the Arkansas Legislative  
25 Council or Joint Budget Committee which relate to its passage and adoption.

26  
27 SECTION 59. EMERGENCY CLAUSE. It is found and determined by the  
28 General Assembly, that the Constitution of the State of Arkansas prohibits  
29 the appropriation of funds for more than a one (1) year period; that the  
30 effectiveness of this Act on July 1, 2023 is essential to the operation of  
31 the agency for which the appropriations in this Act are provided, and that in  
32 the event of an extension of the legislative session, the delay in the  
33 effective date of this Act beyond July 1, 2023 could work irreparable harm  
34 upon the proper administration and provision of essential governmental  
35 programs. Therefore, an emergency is hereby declared to exist and this Act  
36 being necessary for the immediate preservation of the public peace, health

1 and safety shall be in full force and effect from and after July 1, 2023.
