20	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21	
22	SECTION 1. Arkansas Code § 23-60-104(a), concerning the applicability
23	of the Arkansas Insurance Code and rules promulgated by the Insurance
24	Commissioner under the Arkansas Insurance Code, is amended to add an
25	additional subdivision to read as follows:
26	(4)(A) A nonprofit agricultural membership organization.
27	(B) Any risk arising out of a contract for coverage for
28	healthcare services between a member of a nonprofit agricultural membership
29	organization and a nonprofit agricultural membership organization, or its
30	affiliate, may be reinsured by an insurer that is authorized to transact
31	insurance in this state.
32	(C) A nonprofit agricultural membership organization shall
33	pay a levy of the insurance premium tax to the same extent as a domestic
34	<u>insurer under § 26-57-604.</u>

36	SECTION 2. Arkansas Code § 23-60-104(b), concerning definitions used

1	for exceptions to the Arkansas Insurance Code, is amended to add an
2	additional subdivision to read as follows:
3	(3) "Nonprofit agricultural membership organization" means an
4	organization that:
5	(A) Is incorporated under the laws of this state;
6	(B) Has a physical presence in every county of this state;
7	(C) Has a purpose of promoting the interests of farmers or
8	their affiliates in this state;
9	(D) Provides coverage for healthcare services for members
10	and their families pursuant to contracts between members and the organization
11	or its affiliates; and
12	(E)(i) Has a designated individual who, in consultation
13	with the State Insurance Department, operates as an ombudsman to address
14	concerns from insured members regarding the insurance policy.
15	(ii) If a complaint is received by the department
16	from insured members of the nonprofit agricultural membership organization,
17	then the department shall forward the complaints to the designated individual
18	operating as the nonprofit agricultural membership organization's ombudsman
19	under subdivision (b)(3)(E)(i) of this section.

21	SECTION 3. Arkansas Code § 23-76-103(c), concerning the applicability
22	of law concerning hospital and medical service corporations, is amended to
23	read as follows:
24	(c) This chapter does not apply to a:
25	(1) Healthcare sharing ministry as defined in § 23-60-104(b); or
26	(2) Direct healthcare agreement as defined in § 23-60-104(b); or
