29	the agency for which the appropriations in this Act are p	rovided, and that in
30	the event of an extension of the legislative session, the	delay in the
31	effective date of this Act beyond July 1, 2023 could work	irreparable harm
32	upon the proper administration and provision of essential	governmental
33	programs. Therefore, an emergency is hereby declared to e	xist and this Act
34	being necessary for the immediate preservation of the pub	lic peace, health
35	and safety shall be in full force and effect from and aft	er July 1, 2023.
