2	meetings under the Freedom of Information Act of 1967, is amended to read as		
3	follows:		
4	(a) Except as otherwise specifically provided by law, all meetings,		
5	formal or informal, special or regular, of $\underline{\text{two (2)}}$ or more members of the		
6	governing bodies governing body of the following entities are public		
7	meetings:		
8	(1) of all All municipalities, counties, townships, and school		
9	districts, and other political subdivisions;		
10	(2) and all All boards, bureaus, commissions, or organizations,		
11	and other public entities of the State of Arkansas, except grand juries;		
12	(3) All other public entities supported wholly or in part by		
13	public funds or expending public funds, shall be public meetings.; and		
14	(4) All private entities that are:		
15	(A) Supported wholly or in part by public funds or		
16	expending public funds; and		
17	(B) Engaged in activities or the provision of services		
18	that:		
19	(i) Would normally be provided by governmental		
20	entities; or		
21	(ii) Would be provided by governmental entities in		
22	the absence of the private entity.

24	SECTION 3. Arkansas Code § 25-19-106, concerning open public meetings		
25	under the Freedom of Information Act of 1967, is amended to add an additional		
26	subsection to read as follows:		
27	(f) Two (2) or more members of a governing body of a public entity		
28	shall neither discuss, deliberate, nor decide public business of a governing		
29	body of a public entity in circumvention of the spirit or express		
30	requirements of this chapter during any chance interaction, informal		
31	assemblage, or electronic communication.
