28	SECTION 13. DO NOT CODIFY. TEMPORARY LANGUAGE. This act shall not
29	shorten the term of any current member of the Arkansas Catfish Promotion
30	Board, Arkansas Soybean Promotion Board, Arkansas Rice Research and Promotion
31	Board, Arkansas Wheat Promotion Board, Arkansas Corn and Grain Sorghum
32	Promotion Board, and Arkansas Beef Council but shall be implemented as terms
33	expire and by filling vacancies on each of the boards and council.

35	SECTION 14. EMERGENCY CLAUSE. It is found and determined by the
36	General Assembly of the State of Arkansas that the Arkansas Catfish Promotion

1	Board, Arkansas Soybean Promotion Board, Arkansas Rice Research and Promotion
2	Board, Arkansas Wheat Promotion Board, Arkansas Corn and Grain Sorghum
3	Promotion Board, and Arkansas Beef Council preserves the public peace,
4	health, and safety by studying, planning, promoting, and implementing needed
5	projects and research to support the agricultural industry in Arkansas; that
6	this act provides for the transfer of agricultural boards to the Department
7	of Agriculture for more efficient agricultural promotion and industry in the
8	state; and that this act should become effective on July 1, 2023, to coincide
9	with the appropriation bills of the Department of Agriculture and Department
10	of Finance and Administration to continue to provide the vital services of
11	these state entities as the transfer is implemented and does not experience
12	any issues with funding under the transfer. Therefore, an emergency is
13	declared to exist, and this act being necessary for the preservation of the
14	public peace, health, and safety shall become effective on July 1, 2023.
