8	(C) If the commission finds that the public interest will		
9	best be served by allowing the political subdivision to appoint the		
10	additional part-time law enforcement officers requested, the commission may		
11	grant the request under subdivision $\frac{(a)(2)(A)}{(a)(3)(A)}$ of this section.		
12	(b) This section does not restrict the number of honorary police		
13	officers without law enforcement authority.
