engaged, in the production of agriculture on property owned by the member. (iv) One (1) member shall be appointed by the Governor from the state at large subject to confirmation by the Senate. (v) (iii) One (1) member shall be appointed by the Governor after consulting the Arkansas Wildlife Federation and subject to confirmation by the Senate appointed by the Governor shall have an interest in the protection, restoration, and management of the state's habitats, plants, and animals. (B) Three (3) members shall be appointed by the Speaker of the House of Representatives to serve at the pleasure of the Speaker of the House of Representatives. (C) Three (3) members shall be appointed by the President Pro Tempore of the Senate to serve at the pleasure of the President Pro Tempore of the Senate. SECTION 2. DO NOT CODIFY. TEMPORARY LANGUAGE. This act shall not shorten the term of any current member of the Arkansas Natural Heritage Commission but shall be implemented as terms expire and by filling vacancies on the commission.
