24	the payor and a showing of good cause, including without limitation based on
25	evidence that the minor child's needs are not being met, may order the
26	physical custodian, payee, or other person to whom child support may be owed
27	<u>to:</u>
28	(A) Provide the court and the payor with an accounting of
29	expenses that have been paid with child support payments; and
30	(B) Demonstrate to the court how the child support
31	payments were used for the benefit of the minor child or children.
32	(2) The court may prescribe the form, substance, and time frame
33	of the accounting under subdivision (b)(1)(A) of this section.
