14	28-41-105. Affidavit of heirship — Transfer of title and interest in		
15	vehicle.		
16	(a) An heir who is entitled to the transfer or delivery of personal		
17	property for which a certificate of title is required under § 27-14-703 shall		
18	submit an affidavit of heirship to the Office of Motor Vehicle on a form		
19	prescribed by the Office of Motor Vehicle.		
20	(b) An affidavit of heirship properly executed under this section		
21	shall convey to the Office of Motor Vehicle the authority to transfer the		
22	certificate of title of and interest in a vehicle from the owner of the		
23	vehicle to the owner's heir.
