 - (c)(l) The center created by this section shall be the liaison for the division with the United States Office for Civil Rights.
 - (2) The center shall maintain manuals, guidelines, procedures, and other informational materials setting requirements in the area of civil rights desegregation and nondiscrimination and describing how determination of compliance is made.

Retention action plans shall be prepared on a 3 4 continuing basis for future five-year periods. 5 (b) Each state-supported college and university shall annually prepare 6 a progress report on the steps that have been taken to reach the goals of the 7 plan. The report shall include information relative to students, faculty, and 8 staff within the institution. 9 (c) Copies of each institution's five-year plan and annual report 10 shall be filed by June 30 with the Division of Higher Education, the board of 11 trustees of the institution, the House Committee on Education and the Senate 12 Committee on Education, and the board of visitors of the institution, if 13 applicable. 14 (d) The division shall develop appropriate forms for reporting and 15 shall monitor the retention plans and annual reports. 16 (e) In carrying out the retention action plans, each institution shall 17 provide for a part-time or full-time employee by reassignment, appointment, 18 or employment to assist the institution in the retention of blacks and 19 members of other minority groups for faculty and staff positions. 20 21 SECTION 7. (a)(1) Each state-supported institution of higher education shall 23 prepare an affirmative action program for the recruitment of African-24 Americans and other members of minorities for faculty and staff positions and 25 26 for enrollment as students. 27 (2) Affirmative action plans shall be prepared on a continuing 28 basis for future five-year periods. (b)(1) Each state supported institution of higher education shall 29 30 prepare annually a summary report on the steps that have been taken to reach the goals of the plan. 31 32 (2) The report shall: 33 (A) Include information on the progress made by each institution for the various levels of employment within the institution; and 34 35 (B) Be presented in a table format limited to no more than 36 five (5) pages.

1 (c) Copies of the five-year plan and annual reports summaries of each 2 institution of higher education shall be included in the Comprehensive 3 Arkansas Higher Education Annual Report, filed with the Governor, the 4 Division of Higher Education, the president and board of trustees of the 5 institution, the board of visitors of the institution, if applicable, and the 6 House Committee on Education and the Senate Committee on Education. 7 (d) In carrying out the affirmative action plans, each institution of 8 higher education shall provide for a part-time or full-time employee to 9 assist the institution in the recruitment of African-Americans and other 10 members of minorities for faculty and staff positions and for enrollment as 11 students. 12 SECTION 8. Arkansas Code § 6-82-1501 is amended to read as follows: 13 14 6-82-1501. Title. This subchapter shall be known and may be cited as the "Arkansas 15 16 Geographical Critical Needs Minority Teacher Scholarship Program Act of 17 2001". 18 19 SECTION 9. Arkansas Code § 6-82-1502 is amended to read as follows: 20 6-82-1502. Program established - Purpose. 21 There is established the Critical Needs Minority Teacher 22 Scholarship Program. 23 (b) The purpose of the program is to attract qualified minority 24 teachers to the Delta and those geographical areas of the state where there 25 exists a critical shortage of teachers by awarding scholarships to minorities 26 individuals declaring an intention to serve in the teaching field who 27 actually render service to this state while possessing an appropriate 28 teaching license. 29 30 SECTION 10. Arkansas Code § 6-82-1503(a) and (b), concerning the 31 eligibility for scholarships, are amended to read as follows: 32 (a) (1) The term "minority" when used in this subchapter shall refer to 33 Black Americans, Hispanic Americans, Asian Americans, and Native Americans. 34 (2) The Native American group includes all persons having 35 origins in any of the original peoples of North America and who maintain 36 cultural identification through tribal affiliation or community recognition.

- 1 (b) Any individual who is a minority and who is enrolled in or 2 accepted for enrollment at a baccalaureate degree-granting institution of 3 higher education whose teacher education program is approved by the State 4 Board of Education or at an accredited state-supported community college in 5 the State of Arkansas who expresses in writing an intention to teach in a 6 geographical area of the state in which there exists a critical shortage of 7 teachers, as designated by the state board, shall be eligible for a financial 8 Critical Needs Minority Teacher Scholarship to be applied toward the costs of 9 the individual's college education, if:
- 10 (1) The applicant has a grade point average of 2.5 on a 4.0
 11 scale in high school if the applicant graduated within the five (5) preceding
 12 years; and
- 13 (2) The applicant scored nineteen (19) or above on the ACT
 14 composite or the equivalent as defined by the University of Arkansas at Pine
 15 Bluff.

 - "The State of Arkansas does not discriminate in access to employment opportunities or in employment or practices on the basis of race, color, religion, sex, national origin, age, disability, or genetic information."

- SECTION 19. Arkansas Code § 22-9-203(i), concerning the award procedure for public improvements generally, is amended to read as follows:
- (i) No contract providing for the making of major repairs or alterations, for the erection of buildings or other structures, or for making other permanent improvements shall be entered into by the state, any agency of the state, any county, municipality, school district, or other local taxing unit with any contractor in instances where all estimated costs of the work shall exceed the sum of seventy-five thousand dollars (\$75,000) unless the bid documents contain statements which encourage the participation of small, minority, and women's business enterprises.

SECTION 20. Arkansas Code Title 25, Chapter 1, Subchapter 1, is amended to add an additional section to read as follows:

3	(a) As used in this section, "state" means the State of Arkansas, a
4	city, a county, an institution of higher education, a public school district
5	a public special school district, or a political subdivision or governmental
6	instrumentality of the state.
7	(b) The state shall not discriminate against, or grant preferential
8	treatment to, an individual or group on the basis of race, sex, color,
9	ethnicity, or national origin in matters of state employment, public
10	education, or state procurement.
11	(c) This section applies only to an action taken after the effective
12	date of this act.
13	(d) This section does not:
14	(1) Prohibit the consideration by the state of bona fide
15	qualifications based on gender that are reasonably necessary to the normal
16	functions of state employment, public education, or state procurement;
17	(2) Invalidate a court order or consent decree that is in force
18	as of the effective date of this act;
19	(3) Prohibit an action necessary to establish or maintain
20	eligibility for a federal program if ineligibility would demonstrably result
21	in a loss of federal funds to the state; or
22	(4) Preempt state discrimination law or federal discrimination
23	law.
24	(e) A person who negligently violates this section is guilty of a
25	Class A misdemeanor.
26	(f)(l) A person who believes his or her rights have been impacted
27	under this section may bring a civil action in circuit court to:
28	(A) Enjoin a violation of this section; and
29	(B) Recover reasonable court costs and attorney's fees.
30	(2) In an action brought under this section, if the court finds
31	that a violation occurred, the court shall award:
32	(A) Injunctive relief; and
33	(B) Court costs and attorney's fees.

36	SECTION 21 Arkansas Code & 25-36-103 is repealed

2	(a) A state agency shall include in all requests for proposals and
3	requests for qualifications, language that encourages minority participation
4	in each request for proposals and request for qualifications issued by the
5	state agency.
6	(b)(1) State agency requests for proposals and requests for
7	qualifications shall take into consideration minority inclusion in the
8	proposed project.
9	(2) Requests for proposals and requests for qualifications shall
10	provide that an applicant unable to include minority-owned businesses may
11	explain the circumstances preventing minority inclusion.
