- 20 PUBLIC DEFENDERS. (a) No funds appropriated herein shall be used for
- 21 expenses in cases where a defendant is represented by retained counsel where
- 22 retained counsel have not gone through the Public Defender Commission's
- 23 attorney certification procedure and designation process as established by
- 24 state law and the Commission's regulations. All defendants and retained
- 25 attorneys must strictly adhere to the procedure established by the Commission
- 26 to equitably and responsibly monitor and distribute State funds for this
- 27 purpose.
- 28 (b) The Public Defender Commission may approve exemptions to subsection
- 29 (a) as needed. Reasons for granting exemption should be specified in writing.
- The provisions of this section shall be in effect only from July 1, 2022
- 31 <u>2023</u> through June 30, 2023 <u>2024</u>.

- 33 SECTION 19. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
- 34 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
- 35 MAXIMUM SALARY. In order to maintain equity between the prosecutors and
- 36 <u>public defenders</u>, the following classifications are authorized to be paid up

19	SECTION 20. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE
20	ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
21	EXTRA HELP EXEMPTION. The Arkansas Public Defender Commission may utilize
22	their authorized extra help positions up to a maximum of one thousand eight
23	hundred (1,800) hours. The rates of pay may not exceed those provided in the
24	Uniform Classification Act or its successor, for the appropriate
25	<u>classification.</u>
26	The provisions of this section shall be in effect only from July 1,
27	2023 through June 30, 2024.

29	SECTION $21.$ COMPLIANCE WITH OTHER LAWS. Disbursement of funds
30	authorized by this act shall be limited to the appropriation for such agency
31	and funds made available by law for the support of such appropriations; and
32	the restrictions of the State Procurement Law, the General Accounting and
33	Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
34	Procedures and Restrictions Act, or their successors, and other fiscal
35	control laws of this State, where applicable, and regulations promulgated by
36	the Department of Finance and Administration, as authorized by law, shall be

strictly complied with in disbursement of said funds. SECTION 22. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption. SECTION 23. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2023 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the legislative session, the delay in the effective date of this Act beyond July 1, 2023 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2023. /s/Joint Budget Committee
